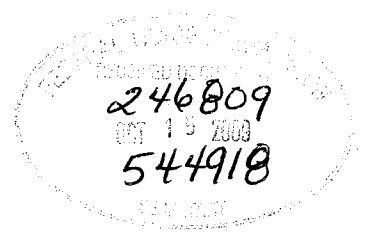

COMPLAINT COUNSEL'S
