Attachment 2B: Beetle and Jetta Mileage Adjustment Table

Instructions to Calculate Your Mileage Adjustment:

1. Check your vehicle's **current mileage**.
2. Based on the current month, multiply the **number of months since September 2015** by **1,042**.
(EX: If the current month is October 2016, multiply 13 months x 1,042 = 13,546)
3. Subtract the number from (2) from your current mileage to get your **Adjusted Mileage** .
4. Find your **Adjusted Mileage** in the chart below, and locate the corresponding adjustment amount for your vehicle's model year.
5. Add or subtract the adjustment dollar amount to your **Buyback** or **Modification** amount from **Attachment 1A**.
6. If the modification amount from (5) is less than \$5,100, see **Further Adjustment** at the end of this table. (This also applies to Buyback).
Otherwise, the result from (5) is your Mileage-Adjusted Buyback or Modification Amount.

Further Adjustment
(applies to both Buyback and Modification)

If the Modification amount from (5) above is less than \$5,100:

- a. Subtract the Modification amount from (5) from \$5,100.
- b. For Buyback: Add the result from (a) to the number from (5) above.
This is your **Mileage-Adjusted Buyback Amount**.
- c. For Modification: Add the result from (a) to the number from (5) above.
This is your **Mileage-Adjusted Modification Amount**.
