Pursuant to Rule 3.22(c) of the Commission Rules of Practice, Complaint Counsel respectfully moves the Court for an order granting Complaint Counsel leave to exceed its 2,500 word limit on its Opposition to Respondent's Expedited Motion for *In Camera* Review.
