Re: Unsubstantiated claims for Coronavirus treatment or prevention

Dear Dr. Skurnowicz:

This is to advise you that FTC staff has reviewed your websites at <a href="https://holgistic.com">https://holgistic.com</a> and <a href="www.naturalcareinstitute">www.naturalcareinstitute</a> on April 28, 2020. We also reviewed your social media websites at <a href="https://www.facebook.com/Holgistic/">https://www.facebook.com/Holgistic/</a> and <a href="https://www.facebook.com/NaturalCareInstitute/">https://www.facebook.com/Holgistic/</a> and <a href="https://holgistic.com">https://holgistic.com</a>, to purchase Vitamin C infusion therapy and supplements, teas, and herbal remedies, including Holgistic's Anti-Viral Organic Tea Blend. We have determined that you are unlawfully advertising that certain products treat or prevent Coronavirus Disease 2019 (COVID-19).

Some examples of Coronavirus treatment or prevention claims on your social media websites include:

- On a Facebook post, posted to <a href="https://www.facebook.com/Holgistic/">https://www.facebook.com/Holgistic/</a> on March 28, 2020 at 9:30 a.m., you state: "With news of Detroit Police Chief James Craig and so many officers from Detroit testing Positive for COVID-19 we would like to extend an offer to all law enforcement of 10% off Vitamin C infusion therapy ~
  - "Appointments available by teleconference with one of our Naturopathic Physicians on ways to build your immune system and stay healthy!! Ask about our 30 minute consultations! ~
  - "... Treating the root, not just your symptoms ~

"Call us today 248-733-5700 – let us help you become a Healthy Warrior!!"

• On a Facebook post, posted to <a href="https://www.facebook.com/Holgistic/">https://www.facebook.com/Holgistic/</a> on March 27, 2020 at 10:54 a.m., you state: "Offering vitamin C infusions to all healthcare workers, police officers and first responders at 10% discount. Get in now while supplies last!!!"

This text appears above a link to an article titled, "Can early and high intravenous dose of vitamin C prevent and treat coronavirus disease 2019 (COVID-19)?" This article, published in Medicine in Drug Discovery in March 2020, states, "The COVID-19 (SARS-2-Cov) pandemic, first reported in Wuhan, China, is now spreading to many continents and countries, causing a severe public health burden. Currently, there is no vaccine or specific antiviral drug for this deadly disease. A quick, deployable and accessible, effective and safe treatment is urgently needed to save lives and curtail the spreading.... Early use of large dose antioxidants, such as vitamin C (VC) may become an effective treatment for these patients. Clinical studies also show that high-dose oral VC provides certain protection against viral infection. Neither intravenous nor oral administration of high-dose VC is associated with significant side effect. Therefore, this regimen should be included in the treatment of COVID-19 and used as a preventative measure for susceptible populations such as healthcare workers with higher exposure risks." Build your immune system now – don't wait until its [sic] too late."

This text appears above a link to an article titled, "Chinese Medical Team Report Successful Treatment of Coronavirus Patients with High-Dose Vitamin C." This article, published on GreenMed*info* on March 11, 2020, states, "A medical team from the Second Affiliated Hospital of Xi'an Jiaotong University in China has reported the successful treatment of coronavirus patients with vitamin C. In a press release posted

on the hospital website, the team describes how patients suffering from severe coronary pneumonia, a potentially fatal complication of the new coronavirus COVID-19, have recovered after being treated with high doses of the vitamin.... Significantly, the press release acknowledges that early application of vitamin C can have a strong antioxidant effect, reduce inflammatory responses, and improve endothelial function.... The medical team say their past experience shows that high-dose vitamin C can not only improve antiviral levels, but more importantly can prevent and treat acute lung injury and acute respiratory distress."

• On a YouTube video posted on March 18, 2020, you state: "... There are other things like ... this is an anti-viral organic tea [holds up a bag of Holgistic brand tea leaves labeled 'Anti-Viral Organic Tea Blend'] that I had made for my office. It's an anti-viral tea blend with lemon balm, rosemary, thyme, skullcap, basil, echinacea, and stevia. And skullcap and rosmarinic acid have been shown in the research to be effective at fighting

Coronavirus. It targets a receptor. So those two things are really great." It is unlawful under the FTC Act, 15 U.S.C. § 41 *et seq.*, to advertise that a product or service can prevent, treat, or cure human disease unless you possess competent and reliable scientific evidence, including, when appropriate, well-controlled human clinical studies, substantiating that the claims are true at the time they are made. For COVID-19, no such study is currently known to exist for the products or services identified above. Thus, any coronavirus-related prevention or treatment claims regarding such products or services are not supported by competent and reliable scientific evidence. You must immediately cease making all such claims.

You are also advised to review all other claims for your products and services and immediately cease making claims that are not supported by competent and reliable scientific evidence.
