15	3. Defendants neither admit nor deny any of the allegations in the
16	Complaint, except as specifically stated in this Order. Only for purposes of this
17 18	action, Defendants admit the facts necessary to establish jurisdiction.
19	4. Defendants waive any claim that they might have under the Equal
20	
21	Access to Justice Act, 28 U.S.C. § 2412 concerning the prosecution of this action
22	through the date of this Order, and agree to bear their own costs and attorney's
23	fees.
24	5. Defendants and the Commission waive all rights to appeal or
25	otherwise shellenge or contest the validity of this Order
26	otherwise challenge or contest the validity of this Order.
27	6. Entry of this Order is in the public interest.

12 13	3. "Individual Defendants" means Emory L. Holley IV a/k/a Jack
14	Holley and Lisa Miller, and by whatever other names each may be known.
15	4. "Debt Relief Product or Service" means any product, service, plan
16 17	or program represented, directly or by implication, to renegotiate, settle, or in any
18	way alter the terms of payment or other terms of the debt between a person and
19	one or more unsecured creditors or debt collectors, including, but not limited to, a
20 21	reduction in the balance, interest rate, or fees owed by a person to an unsecured
22	creditor or debt collector.
23	5. <b>"Financial Related Product or Service</b> " means any product or
24	service represented, directly or by implication, to: (a) provide any consumer,
25 26	arrange for any consumer to receive, or assist any consumer in receiving, credit,
20	debit, or stored value cards; (b) improve, or arrange to improve, any consumer's
28	

1	credit record, credit history, or credit rating; (c) provide advice or assistance to
2	any consumer with regard to any activity or service the purpose of which is to
3	improve a consumer's credit record, credit history, or credit rating; (d) provide
4	
5	any consumer, arrange for any consumer to receive, or assist any consumer in
6	receiving, a loan or other extension of credit; or (e) provide any consumer,
7	arrange for any consumer to receive, or assist any consumer in receiving any
8	
9	service represented, expressly or by implication, to renegotiate, settle, or in any
10	way alter the terms of payment or other terms of the debt between a consumer
11	and one or more secured creditors, servicers, or debt collectors.
12	
13	6. <b>"Telemarketing</b> " means any plan, program, or campaign which is
14	conducted to induce the purchase of goods or services, or a charitable
15	contribution, by use of one or more telephones, and which involves a telephone
16	
17	call, whether or not covered by the Telemarketing Sales Rule, but does not
18	include telephone calls in which the sale of goods and services is not completed,
19	and payment or authorization of payment is not required, until after a face-to-face
20	sales presentation.

Disclosing, using, or benefitting from customer information, 12 including the name, address, telephone number, email address, social security 13 number, other identifying information, or any data that enables access to a 14 15 customer's account (including a credit card, bank account, or other financial 16 account), that any Defendant obtained prior to entry of this Order in connection 17 with the marketing or sale of any Debt Relief Product or Service; and 18 19 C. Failing to destroy such customer information in all forms in their 20 possession, custody, or control within thirty (30) days after entry of this Order. 21 *Provided, however, that customer information need not be disposed of, and may* 22 23 be disclosed, to the extent requested by a government agency or required by a 24 law, regulation, or court order. 25 26 27 28

1	IX. PROHIBITION ON COLLECTING ON ACCOUNTS
2	IT IS FURTHER ORDERED that Defendants, and Defendants' officers,
3	agents, servants, employees, attorneys, and all other persons in active concert or
4 5	participation with any of them who receive actual notice of this Order, whether
6	acting directly, or indirectly, are permanently restrained and enjoined from
7	attempting to collect, collecting, or assigning any right to collect payment from
8	
9	any consumer who purchased or agreed to purchase any Debt Relief Product or
10	Service from any Defendant.
11	X. RECEIVERSHIP TERMINATION
12	IT IS FURTHER ORDERED that the Receiver must complete all duties
13	within one-hundred eighty (180) days after entry of this Order, but any party or
14	whill one-number eighty (180) days after entry of this Order, but any party of
15 16	the Receiver may request that the Court extend the Receiver's term for good
16 17	cause.

 any business that such Defendant, individually or collectively with any other
 Defendant, is a majority owner or controls directly or indirectly, must create and
 retain the following records:

A. Accounting records showing the revenues from all goods or services
sold;

B. Personnel records showing, for each person providing services,
whether as an employee or otherwise, that person's: name, addresses, and

A copy of each unique advertisement or other marketing material. 9 **XIV. COMPLIANCE MONITORING** 10 11 IT IS FURTHER ORDERED that, for the purpose of monitoring 12 Defendants' compliance with this Order, including the financial representations 13 upon which part of the judgment was suspended and any failure to transfer any 14 15 assets as required by this Order: 16 A. Within fourteen (14) days of receipt of a written request from a 17 representative of the Commission, each Defendant must: submit additional 18 19 compliance reports or other requested information, which must be sworn under 20 penalty of perjury; appear for depositions; and produce documents for inspection 21 and copying. The Commission is also authorized to obtain discovery, without 22 23 further leave of court, using any of the procedures prescribed by Federal Rules of 24 Civil Procedure 29, 30 (including telephonic depositions), 31, 33, 34, 36, 45, and 25 69; 26 27 28

B. For matters concerning this Order, the Commission is authorized to 1 2 communicate directly with each Defendant. Defendant must permit 3 representatives of the Commission to interview any employee or other person 4 affiliated with any Defendant who has agreed to such an interview. The person 5 interviewed may have counsel present; and 6 7 C. The Commission may use all other lawful means, including posing, 8 through its representatives as consumers, suppliers, or other individuals or 9 entities, to Defendants or any individual or entity affiliated with Defendants, 10 11 without the necessity of identification or prior notice. Nothing in this Order 12 limits the Commission's lawful use of compulsory process, pursuant to Sections 9 13 and 20 of the FTC Act, 15 U.S.C. §§ 49, 57b-1. 14 15 **XV.
