**JOINT MOTION TO

1 On December 9, 2014, this Court granted the joint motion of Plaintiff Federal Trade
2 Commission (“FTC”) and Defendants AMG Services, Inc. and MNE Services, Inc. (the “Miami
3 Defendants”) to stay the action between them, pending the FTC’s vote on a proposed settlement
4 between those parties. (ECF No. 712.) The Court excepted from its stay proceedings related to
5 the Intervenor’s request to unseal portions of the Court’s file. (*Id.*) The FTC has since voted to
6 approve a settlement with the Miami Defendants.

7 Now, therefore, the FTC and the Miami Defendants, through their undersigned counsel,
8 jointly move this Court for an order entering the attached proposed Stipulated Order for
9 Permanent Injunction and Monetary Judgment, attached to this motion.
