#### **ORDERED AND ADJUDGED** as follows:

- Judgment is entered in favor of Plaintiff, the Federal Trade Commission, and against Defendant Centro Natural Corp.
- The Federal Trade Commission shall recover from Centro Natural the amount of \$1,588,141, consisting of unreimbursed consumer injury.
- 3. This judgment shall bear interest at the rate as prescribed by 28 U.S.C. section 1961, and shall be enforceable as prescribed by 28 U.S.C. sections 2001, et seq., 28 U.S.C. sections 3001–3308, and Federal Rule of Civil Procedure 69(a).
