14 Plaintiff, the Federal Trade Commission (“Commission” or “FTC”), filed
15 its Complaint for Injunctive and Other Equitable Relief (“Complaint”) in this
16 matter, pursuant to Sections 13(b) and 19 of the Federal Trade Commission Act
17 (“FTC Act”), 15 U.S.C. §§ 53(b) and 57b. The Commission and Defendants
18 stipulate to the entry of this Stipulated Order for Permanent Injunction and
19 Monetary Judgment (“Order”) to resolve all matters in dispute in this action
20 between them.

21
22 THEREFORE, IT IS ORDERED as follows:

23 **FINDINGS**

- 24 1. This Court has jurisdiction over this matter.
25
26 2. The Complaint charges that Defendants participated in deceptive acts or
27 practices in violation of Section 5 of the FTC Act, 15 U.S.C. § 45, and in
28

1 deceptive or abusive acts or practices in violation of the Telemarketing Sales
2 Rule, 16 C.F.R. Part 310, in the marketing and sale of student loan debt relief
3 services.
4

5 3. Defendants neither admit nor deny any of the allegations in the Complaint,
6 except as specifically stated in this Order. Only for purposes of this action,
7 Defendants admit the facts necessary to establish jurisdiction.
8

9 4. Defendants waive any claim that they may have under the Equal Access to
10 Justice Act, 28 U.S.C. § 2412, concerning the prosecution of this action through
11 the date of this Order, and agree to bear their own costs and attorney fees.
12

13 5. Defendants and the Commission waive all rights to appeal or otherwise
14 challenge or contest the validity of this Order.
15

17 **DEFINITIONS**
18

19 For the purpose of this Order, the following definitions apply:

20 A. **“Assisting Others”** includes:

- 21 1. performing customer service functions, including receiving or
22 responding to consumer complaints;
- 23 2. formulating or providing, or arranging for the formulation or
24 provision of, any advertising or marketing material, including any
25 telephone sales script, direct mail solicitation, or the design, text, or
26
27
28

1 use of images of any Internet website, email, or other electronic
2 communication;

- 3
- 4 3. formulating or providing, or arranging for the formulation or
5 provision of, any marketing support material or service, including
6 web or Internet Protocol addresses or domain name registration for
7 any Internet websites, affiliate marketing services, or media
8 placement services;
- 9
- 10 4. providing names of, or assisting in the generation of, potential
11 customers;
- 12
- 13 5. performing marketing, billing, or payment services of any kind; or
14
- 15 6. acting or serving as an owner, officer, director, manager, or principal
16 of any entity.

17 **B. “Clear(ly) and Conspicuous(ly)”** means that a required disclosure is
18 difficult to miss (i.e., easily noticeable) and easily understandable by ordinary
19 consumers, including in all of the following ways:

- 20
- 21 1. In any communication that is solely visual or solely audible, the
22 disclosure must be made through the same means through which the
23 communication is presented. In any communication made through
24 both visual and audible means, such as a television advertisement, the
25 disclosure must be presented simultaneously in both the visual and
26

28

1 audible portions of the communication even if the representation
2 requiring the disclosure is made in only one means.

- 3
- 4 2. A visual disclosure, by its size, contrast, location, the length of time it
5 appears, and other characteristics, must stand out from any
6 accompanying text or other visual elements so that it is easily
7 noticed, read, and understood.
- 8
- 9 3. An audible disclosure, including by telephone or streaming video,
10 must be delivered in a volume, speed, and cadence sufficient for
11 ordinary consumers to easily hear and understand it.
- 12
- 13 4. In any communication using an interactive electronic medium, such
14 as the Internet or software, the disclosure must be unavoidable.
- 15
- 16 5. On a product label, the disclosure must be presented on the principal
17 display panel.
- 18
- 19 6. The disclosure must use diction and syntax understandable to
20 ordinary consumers and must appear in each language in which the
21 representation that requires the disclosure appears.
- 22
- 23 7. The disclosure must comply with these requirements in each medium
24 through which it is received, including all electronic devices and
25 face-to-face communications.
26
27
28

1 8. The disclosure must not be contradicted or mitigated by, or
2 inconsistent with, anything else in the communication.

3
4 9. When the representation or sales practice targets a specific audience,
5 such as children, the elderly, or the terminally ill, “ordinary
6 consumers” includes reasonable members of that group.

7
8 C. “**Close Proximity**” means that the disclosure is very near the triggering
9 representation. For example, a disclosure made through a hyperlink, pop-up,
10 interstitial, or other similar technique is not in Close Proximity to the triggering
11 representation.

12
13 D. “**Defendants**” means the Individual Defendant and the Corporate
14 Defendants, individually, collectively, or in any combination.

15
16 E. “**Corporate Defendants**” means SLAC, Inc., also doing business as
17 Student Loan Assistance Center, Navloan, Inc., and Student Loan Assistance
18 Center, LLC, and their successors and assigns.

19
20 F. “**Individual Defendant**” means Adam Owens.

21
22 G. “**Financial Product or Service**” means any product, service, plan, or
23 program represented, expressly or by implication, to:

24 1. provide any consumer, arrange for any consumer to receive, or assist
25 any consumer in receiving, a loan or other extension of credit;
26
27
28

- 1 2. provide any consumer, arrange for any consumer to receive, or assist
2 any consumer in receiving, credit, debit, or stored value cards;
- 3
4 3. improve, repair, or arrange to improve or repair, any consumer's
5 credit record, credit history, or credit rating; or
- 6
7 4. provide advice or assistance to improve any consumer's credit
8 record, credit history, or credit rating.

9 **H. "Secured or Unsecured Debt Relief Product or Service" means:**

- 10 1. With respect to any mortgage, loan, debt, or obligation between a
11 person and one or more secured or unsecured creditors or debt
12 collectors, any product, service, plan, or program represented,
13 expressly or by implication, to:
 - 14 a. stop, prevent, or postpone any mortgage or deed of foreclosure
15 sale for a person's dwelling, any other sale of collateral, any
16 repossession of a person's dwelling or other collateral, or
17 otherwise save a person's dwelling or other collateral from
18 foreclosure or repossession;
 - 19 b. negotiate, obtain, or arrange a modification, or renegotiate,
20 settle, or in any way alter the terms of the mortgage, loan, debt,
21 or obligation, including a reduction in the amount of interest,

1 principal balance, monthly payments, or fees owed by a person
2 to a secured or unsecured creditor or debt collector;

3
4 c. obtain any forbearance or modification in the timing of
5 payments from any secured or unsecured holder or servicer of
6 any mortgage, loan, debt, or obligation;

7
8 d. negotiate, obtain, or arrange any extension of the period of
9 time within which a person may (i) cure his or her default on
10 the mortgage, loan, debt, or obligation, (ii) reinstate his or her
11 mortgage, loan, debt, or obligation, (iii) redeem a dwelling or
12 other collateral, or (iv) exercise any right to reinstate the
13 mortgage, loan, debt, or obligation, or redeem a dwelling or
14 other collateral;

15
16 e. obtain any waiver of an acceleration clause or balloon payment
17 contained in any promissory note or contract secured by any
18 dwelling or other collateral; or

19
20 f. negotiate, obtain, or arrange (i) a short sale of a dwelling or
21 other collateral, (ii) a deed-in-lieu of foreclosure, or (iii) any
22 other disposition of a mortgage, loan, debt, or obligation other
23 than a sale to a third party that is not the secured or unsecured
24 loan holder.

- 1 2. With respect to any loan, debt, or obligation between a person and
2 one or more unsecured creditors or debt collectors, any product,
3 service, plan, or program represented, expressly or by implication, to:
4 a. repay one or more unsecured loans, debts, or obligations; or
5 b. combine unsecured loans, debts, or obligations into one or
6 more new loans, debts, or obligations.
7

9 I. **“Telemarketing”** means any plan, program, or campaign which is
10 conducted to induce the purchase of goods or services or a charitable contribution
11 by use of one or more telephones, and which involves a telephone call, whether or
12 not covered by the Telemarketing Sales Rule.
13

14 J. **“Unexpected Material Connection”** means any relationship to (1) any
15 Defendant or (2) any other individual or entity affiliated with any Defendant’s
16 product, service, plan, or program, that might materially affect the weight or
17 credibility of a testimonial or endorsement and that would not reasonably be
18 expected by consumers.

23 **ORDER**

24 **I. BAN ON SECURED OR UNSECURED DEBT RELIEF**
25 **PRODUCTS OR SERVICES**

26 IT IS ORDERED that Defendants are permanently restrained and enjoined
27 from advertising, marketing, promoting, offering for sale, or selling, or Assisting
28

1 Others in the advertising, marketing, promoting, offering for sale, or selling of,
2 any Secured or Unsecured Debt Relief Product or Service.
3

4
5 **II. PROHIBITION AGAINST MISREPRESENTATIONS**
6 **WHEN TELEMARKETING**

7 IT IS FURTHER ORDERED that Defendants, Defendants' officers, agents,
8 employees, and attorneys, and all other persons in active concert or participation
9 with any of them, who receive actual notice of this Order, whether acting directly
10 or indirectly, in connection with Telemarketing any product, service, plan, or
11 program, are permanently restrained and enjoined from:
12

13
14 A. making, or Assisting Others in making, a false or misleading statement to
15 induce any person to pay for goods or services or to induce a charitable
16 contribution;
17

18 B. misrepresenting, or Assisting Others in misrepresenting, any material aspect
19 of the performance, efficacy, nature, or central characteristics of goods or services
20 that are the subject of a sales offer; or
21

22 C. violating, or Assisting Others in violating, the Telemarketing Sales Rule, 16
23 C.F.R. Part 310, a copy of which is attached as Attachment A.
24

1 **III. PROHIBITION AGAINST MISREPRESENTATIONS RELATING**
2 **TO FINANCIAL PRODUCTS AND SERVICES**

3 IT IS FURTHER ORDERED that Defendants, Defendants’ officers, agents,
4 employees, and attorneys, and all other persons in active concert or participation
5 with any of them, who receive actual notice of this Order, whether acting directly
6 or indirectly, in connection with the advertising, marketing, promoting, offering
7 for sale or selling of any Financial Product or Service, are permanently restrained
8 and enjoined from misrepresenting or Assisting Others in misrepresenting,
9 expressly or by implication:
10

11 A. the terms or rates that are available for any loan or other extension of credit,
12 including:
13

- 14 1. closing costs or other fees;
- 15 2. the payment schedule, monthly payment amount(s), any balloon
16 payment, or other payment terms;
- 17 3. the interest rate(s), annual percentage rate(s), or finance charge(s),
18 or whether they are fixed or adjustable;
- 19 4. the loan amount, credit amount, draw amount, or outstanding
20 balance; the loan term, draw period, or maturity; or any other term
21 of credit;

5. the amount of cash to be disbursed to the borrower out of the proceeds, or the amount of cash to be disbursed on behalf of the borrower to any third parties;

6. whether any specified minimum payment amount covers both interest and principal, or whether the credit has or can result in negative amortization; or

7. that the credit does not have a prepayment penalty or whether subsequent refinancing may trigger a prepayment penalty and/or other fees;

B. the ability to improve or otherwise affect a consumer's credit record, credit history, credit rating, or ability to obtain credit, including that a consumer's credit record, credit history, credit rating, or ability to obtain credit can be improved by permanently removing current, accurate negative information from the consumer's credit record or history;

C. that a consumer will receive legal representation; or

D. any other fact material to consumers concerning any Financial Product or Service, such as: its total costs; any material restrictions, limitations, or conditions on its use; or any material aspect of its performance, efficacy, nature, or central characteristics.

1 **IV. PROHIBITION AGAINST MISREPRESENTATIONS RELATING**
2 **TO ANY PRODUCTS, SERVICES, PLANS, OR PROGRAMS**

3 IT IS FURTHER ORDERED that Defendants, Defendants’ officers, agents,
4 employees, and attorneys, and all other persons in active concert or participation
5 with any of them, who receive actual notice of this Order, whether acting directly
6 or indirectly, in connection with the advertising, marketing, promoting, offering
7 for sale, or selling of any product, service, plan, or program, are permanently
8 restrained and enjoined from misrepresenting or Assisting Others in
9
10 restrained and enjoined from misrepresenting or Assisting Others in
11 misrepresenting, expressly or by implication:

12 A. that Defendants will accurately instruct consumers as to applicable statutes
13 and regulations;

14 B. that Defendants will accurately state on forms and applications completed
15 on behalf of consumers the information reported to Defendants by consumers;

16 C. that any person is affiliated with, endorsed, approved by, accredited by, or
17 otherwise connected to any other person, government entity, public, non-profit, or
18 other non-commercial program, or any other program; or
19
20 other non-commercial program, or any other program; or

21 D. any other fact material to consumers concerning any good or service, such
22 as: its total costs; any material restrictions, limitations, or conditions on its use; or
23 any material aspect of its performance, efficacy, nature, or central characteristics.

1 **V. PROHIBITION AGAINST UNSUBSTANTIATED CLAIMS**

2 IT IS FURTHER ORDERED that Defendants, Defendants’ officers, agents,
3 employees, and attorneys, and all other persons in active concert or participation
4 with any of them, who receive actual notice of this Order, whether acting directly
5 or indirectly, in connection with the advertising, marketing, promoting, offering
6 for sale, or selling of any Financial Product or Service, are permanently restrained
7 and enjoined from making any representation or Assisting Others in making any
8 representation, expressly or by implication, about the benefits, performance, or
9 efficacy of any Financial Product or Service, unless the representation is
10 non-misleading, and, at the time such representation is made, Defendants possess
11 and rely upon competent and reliable evidence that is sufficient in quality and
12 quantity based on standards generally accepted in the relevant fields, when
13 considered in light of the entire body of relevant and reliable evidence, to
14 substantiate that the representation is true.

21 **VI. INJUNCTION CONCERNING ENDORSEMENTS AND**
22 **TESTIMONIALS**

23 IT IS FURTHER ORDERED that Defendants, Defendants’ officers, agents,
24 employees, and attorneys, and all other persons in active concert or participation
25 with any of them, who receive actual notice of this Order, whether acting directly
26 or indirectly, in connection with the advertising, marketing, promoting, offering
27
28

1 for sale, or selling of any product, service, plan, or program, are permanently
2 restrained and enjoined from, expressly or by implication:

3
4 A. misrepresenting, or Assisting Others in misrepresenting, that consumer
5 reviews of Defendants' goods or services on any internet site, including but not
6 limited to any Better Business Bureau internet site, reflect the independent
7 opinions or experiences of ordinary impartial consumers;

8
9 B. making any representation about or referral to, or Assisting Others in
10 making any representation about or referral to, any internet site containing reviews
11 or endorsements, including but not limited to representations about or referrals to
12 any Better Business Bureau internet site, without disclosing Clearly and
13 Conspicuously and in Close Proximity to the representation or referral that some
14 of the reviews on the site are by reviewers or endorsers with Unexpected Material
15 Connections, when such is the case; or

16
17 C. failing to disclose, or Assisting Others in failing to disclose, in any response
18 to, or commentary on, any review or endorsement, any Unexpected Material
19 Connection, including but not limited to Defendants' promise to compensate the
20 reviewer or endorser for a positive review.

1 **VII. MONITORING OF REVIEWERS AND ENDORSERS**

2 IT IS FURTHER ORDERED that Defendants, Defendants’ officers, agents,
3 employees, and attorneys, and all other persons in active concert or participation
4 with any of them, who receive actual notice of this Order, whether acting directly
5 or indirectly, in connection with the advertising, promotion, offering for sale, or
6 sale of any product, service, plan, or program, are permanently restrained and
7 enjoined from, expressly or by implication:
8

9
10 A. compensating or offering to compensate any reviewer or endorser for any
11 review or endorsement without providing such reviewer or endorser a clear
12 statement of his or her responsibilities to disclose, Clearly and Conspicuously and
13 in Close Proximity to the review or endorsement, the reviewer’s or endorser’s
14 Unexpected Material Connection and obtaining from each such reviewer or
15 endorser a signed and dated statement acknowledging receipt of that statement
16 and expressly agreeing to comply with it;
17

18
19 B. failing to monitor the representations and disclosures of reviewers and
20 endorsers with material connections to any Defendant or any other individual or
21 entity affiliated with the product, service, plan, or program to ensure that they are
22 making the required disclosures;
23

24
25 C. compensating any reviewer or endorser with an Unexpected Material
26 Connection who Defendants reasonably conclude:
27
28

1. has misrepresented, in any manner, his or her independence or impartiality; or
2. has failed to disclose, Clearly and Conspicuously, and in Close Proximity to the review or endorsement, the Unexpected Material Connection;

D. failing to contact the owner or operator of any internet site containing one or more reviews or endorsements from persons with undisclosed Unexpected Material Connections and request that the review(s) or endorsement(s) be removed from the site; *provided, however*, that Defendants may postpone contacting the owner or operator of the site for five (5) days after learning that the site contains reviews or endorsements with undisclosed Unexpected Material Connections. If, within those five days, a review or endorsement discloses the Unexpected Material Connection Clearly and Conspicuously and in Close Proximity, Defendants need not ask the owner or operator of the site to remove that review or endorsement; and

E. failing to create reports showing the results of the monitoring required by this Section of this Order.

VIII. MONETARY JUDGMENT

IT IS FURTHER ORDERED that:

A. Judgment in the amount of Twenty-Three Million Nine Hundred Twenty Thousand Six Hundred Ninety Dollars (\$23,920,690) is entered in favor of the Commission against the Individual Defendant and the Corporate Defendants, jointly and severally, as equitable monetary relief.

B. Defendants are ordered to pay to the Commission Three Hundred Fifty Thousand Dollars (\$350,000), which, as Defendants stipulate, their undersigned counsel holds in escrow for no purpose other than payment to the Commission. Such payment must be made within seven (7) days of entry of this Order by electronic fund transfer in accordance with instructions previously provided by a representative of the Commission.

C. Defendants are ordered to assign to the Commission all of their right, title, and interest in the judgment in *SLAC, Inc., v. Mia Marketing Group, LLC*, No. RIC1515403, Superior Court, State of California, Riverside County, entered on or about February 22, 2018. Defendants represent and stipulate that the amount of the judgment was One Hundred Twenty-Three Thousand Five Hundred Sixty-Five Dollars and Fifty-Five Cents (\$123,565.55) and that Zero Dollars and Zero Cents (\$0.00) has been collected. Defendants are ordered to cooperate fully with the Commission’s efforts to collect this judgment, including but not limited to

1 executing any documents appropriate to effectuate the transfer, providing such
2 information and documents reasonably necessary for the Commission to collect
3 the judgment, and appearing for interviews, discovery, hearings, trials, and any
4 other proceedings that a Commission representative may reasonably request upon
5 5 days written notice, or other reasonable notice, at such places and times as a
6 Commission representative may designate, without the service of a subpoena.
7

8
9 D. Defendants are ordered to pay to the FTC any refunds, overpayments, or
10 credits, including any interest thereon, received from or on behalf of the California
11 Franchise Tax Board or the United States Internal Revenue Service related in any
12 way to tax years 2015, 2016, 2017, or 2018 within seven (7) days of receipt of the
13 refund, overpayment, or credit.
14

15
16 E. Upon such payments and other asset transfer, as specified in Subsections B,
17 C, and D of this Section, the remainder of the judgment specified in Subsection A
18 is suspended, subject to the Subsections below.
19

20 F. The Commission's agreement to the suspension of the judgment is
21 expressly premised upon the truthfulness, accuracy, and completeness of
22 Defendants' sworn financial statements and related documents (collectively,
23 "Financial Representations") submitted to the Commission, namely:
24

- 25 1. The Financial Statement of Individual Defendant Adam Owens

12 G. The suspension of the judgment will be lifted as to all Defendants if, upon
13 motion by the Commission, the Court finds that any Defendant failed to disclose
14 any material asset, materially misstated the value of any asset, or made any other
15 material misstatement or omission in the Financial Representations identified
16 above.

18 H. If the suspension of the judgment is lifted, the judgment becomes
19 immediately due as to all Defendants in the amount specified in Subsection A
20 above (which the parties stipulate only for purposes of this Section represents the
21 consumer injury alleged in the Complaint), less any payment previously made
22 pursuant to this Section, plus interest computed from the date of entry of this
23 Order.

IX. ADDITIONAL MONETARY PROVISIONS

IT IS FURTHER ORDERED that:

A. Defendants relinquish dominion and all legal and equitable right, title, and interest in all assets transferred pursuant to this Order and may not seek the return of any assets.

B. The facts alleged in the Complaint will be taken as true, without further proof, in any subsequent civil litigation by or on behalf of the Commission, including in a proceeding to enforce its rights to any payment or monetary judgment pursuant to this Order, such as a nondischargeability complaint in any bankruptcy case.

C. The facts alleged in the Complaint establish all elements necessary to sustain an action by the Commission pursuant to Section 523(a)(2)(A) of the Bankruptcy Code, 11 U.S.C. § 523(a)(2)(A), and this Order will have collateral estoppel effect for such purposes.

D. Defendants acknowledge that their Taxpayer Identification Numbers (Social Security Numbers or Employer Identification Numbers), which Defendants must submit to the Commission, may be used for collecting and reporting on any delinquent amount arising out of this Order, in accordance with 31 U.S.C. § 7701.

1 E. All money paid to the Commission pursuant to this Order may be deposited
2 into a fund administered by the Commission or its designee to be used for
3 equitable relief, including consumer redress and any attendant expenses for the
4 administration of any redress fund. If a representative of the Commission decides
5 that direct redress to consumers is wholly or partially impracticable or money
6 remains after redress is completed, the Commission may apply any remaining
7 money for such other equitable relief (including consumer information remedies)
8 as it determines to be reasonably related to Defendants' practices alleged in the
9 Complaint. Any money not used for such equitable relief is to be deposited to the
10 U.S. Treasury as disgorgement. Defendants have no right to challenge any actions
11 the Commission or its representatives may take pursuant to this Subsection.

17 **X. INJUNCTION CONCERNING NOTIFICATION TO EXISTING**
18 **CUSTOMERS REGARDING OPTION TO CANCEL**

19 IT IS FURTHER ORDERED that:

22 adequate and timely notice of this Order by email (if an email address was
23 provided and the email address does not end in "icloud78.com" or
24 "rocketmail16.com") or United States Postal Service (if an email address was not

14 opt-in confirmation stating that the customer wishes to continue receiving services

18 C. Notwithstanding any other provision of this Order, Defendants shall, within
19 thirty (30) days of a written request, provide the Commission with all records
20 reasonably requested about each customer to whom a notice is sent pursuant to
21 Subsection A of this Section, which records may include some or all of the
22 following: name; all known addresses, telephone numbers, email addresses;
23 whether the customer submitted an opt-in confirmation; and copies of all

4 5 **XI. CUSTOMER INFORMATION**

8 any of them, who receive actual notice of this Order, are permanently restrained
9 and enjoined from directly or indirectly:

2 possession, custody, or control within 30 days after receipt of written direction to
3 do so from a representative of the Commission.

5 *Provided, however,* that customer information need not be disposed of, and
6 may be disclosed, to the extent requested by a government agency or required by
7 law, regulation, or court order.
8

9 *Provided further,* that this Section shall not prevent Defendants from
10 disclosing or using information about customers who (1) have received the notice
11 required by Subsection X.A of this Order (titled Injunction Concerning
12 Notification to Existing Customers Regarding Option to Cancel) and (2) have
13 provided Defendants with an opt-in confirmation stating that the customer wishes
14 to continue receiving services from Defendants, provided for in Subsection X.B of
15 this Order (titled Injunction Concerning Notification to Existing Customers
16 Regarding Option to Cancel) (opt-in customers), for the sole purpose of preparing
17 and submitting applications to the Department of Education, or a loan servicing
18 company with which the Department of Education has contracted, to assist such
19 opt-in customer with applying for a deferment, forbearance, repayment plan, loan
20 forgiveness program, or other benefit, available to federal student loan borrowers.

24 reason and in any manner, that customer's information shall not be used by

22 occur within 7 days of entry of this Order for current personnel. For all others,
23 delivery must occur before they assume their responsibilities.

7 address; such calls shall be provided within seven (7) days of a request from the
8 consumer, the consumer's agent, the consumer's bank, or any law enforcement

13 **XV. COMPLIANCE MONITORING**

14 IT IS FURTHER ORDERED that, for the purpose of monitoring
15 Defendants' compliance with this Order, including the Financial Representations
16 upon which part of the judgment was suspended and any failure to transfer any

20 A. Within 14 days of receipt of a written request from a representative of the
21 Commission, each Defendant must: submit additional compliance reports or other
22 requested information, which must be sworn under penalty of perjury; appear for
23 depositions; and produce documents for inspection and copying. The
24 Commission is also authorized to obtain discovery, without further leave of court,

1 using any of the procedures prescribed by Federal Rules of Civil Procedure 29, 30

4 B. For matters concerning this Order, the Commission is authorized to

10 C. The Commission may use all other lawful means, including posing, through

13 necessity of identification or prior notice. Nothing in this Order limits the
14 Commission's lawful use of compulsory process, pursuant to Sections 9 and 20 of
15 the FTC Act, 15 U.S.C. §§ 49, 57b-1.



§310.1 Scope of regulations in this part.

This part implements the Telemarketing and Consumer Fraud and Abuse Prevention Act, 15 U.S.C. 6101-6108, as amended.

§310.2 Definitions.

(a) *Acquirer* means a business organization, financial institution, or an agent of a business organization or financial institution that has authority from an organization that operates or licenses a credit card system to authorize merchants to accept, transmit, or process payment by credit card through the credit card system for money, goods or services, or anything else of value.

(b) *Attorney General* means the chief legal officer of a state.

(c) *Billing information* means any data that enables any person to access a customer's or donor's account, such as a credit card, checking, savings, share or similar account, utility bill, mortgage loan account, or debit card.

(d) *Caller identification service* means a service that allows a telephone subscriber to have the telephone number, and, where available, name of the calling party transmitted contemporaneously with the telephone call, and displayed on a device in or connected to the subscriber's telephone.

(e) *Cardholder* means a person to whom a credit card is issued or who is authorized to use a credit card on behalf of or in addition to the person to whom the credit card is issued.

(f) *Cash-to-cash money transfer* means the electronic (as defined in section 106(2) of the Electronic Signatures in Global and National Commerce Act (15 U.S.C. 7006(2))) transfer of the value of cash received from one person to another person in a different location that is sent by a money transfer provider and received in the form of cash. For purposes of this definition, *money transfer provider* means any person or financial institution that provides cash-to-cash money transfers for a person in the normal course of its business, whether or not the person holds an account with such person or financial institution. The term *cash-to-cash money transfer* includes a remittance transfer, as defined in section 919(g)(2) of the Electronic Fund Transfer Act ("EFTA"), 15 U.S.C. 1693a, that is a cash-to-cash transaction; however it does not include any transaction that is:

(1) An electronic fund transfer as defined in section 903 of the EFTA;

(2) Covered by Regulation E, 12 CFR 1005.20, pertaining to gift cards; or

(3) Subject to the Truth in Lending Act, 15 U.S.C. 1601 *et seq.*

(g) *Cash reload mechanism* is a device, authorization code, personal identification number, or other security measure that make it possible for a person to convert cash into an electronic (as defined in section 106(2) of the Electronic Signature in Global and National Commerce Act (15 U.S.C. 7006(2))) form that can be used to add funds to a general-use prepaid card, as defined in Regulation E, 12 CFR 1005.2, or an account with a payment intermediary. For purposes of this definition, a cash reload mechanism is not itself a general-use prepaid debit card or a swipe reload process or similar method in which funds are added directly onto a person's own general-use prepaid card or account with a payment intermediary.

(h) *Charitable contribution* means any donation or gift of money or any other thing of value.

(i) *Commission* means the Federal Trade Commission.

(j) *Credit* means the right granted by a creditor to a debtor to defer payment of debt or to incur debt and defer its payment.

(k) *Credit card* means any card, plate, coupon book, or other credit device existing for the purpose of obtaining money, property, labor, or services on credit.

(l) *Credit card sales draft* means any record or evidence of a credit card transaction.

(m) *Credit card system* means any method or procedure used to process credit card transactions involving credit cards issued or licensed by the operator of that system.

(n) *Customer* means any person who is or may be required to pay for goods or services offered through telemarketing.

(o) *Debt relief service* means any program or service represented, directly or by implication, to renegotiate, settle, or in any way alter the terms of payment or other terms of the debt between a person and one or more unsecured creditors or debt collectors, including, but not limited to, a reduction in the balance, interest rate, or fees owed by a person to an unsecured creditor or debt collector.

(p) *Donor* means any person solicited to make a charitable contribution.

(q) *Established business relationship* means a relationship between a seller and a consumer based on:

(1) the consumer's purchase, rental, or lease of the seller's goods or services or a financial transaction between the consumer and seller, within the eighteen (18) months immediately preceding the date of a telemarketing call; or

(2) the consumer's inquiry or application regarding a product or service offered by the seller, within the three (3) months immediately preceding the date of a telemarketing call.

(r) *Free-to-pay conversion* means, in an offer or agreement to sell or provide any goods or services, a provision under which a customer receives a product or service for free for an initial period and will incur an obligation to pay for the product or service if he or she does not take affirmative action to cancel before the end of that period.

(s) *Investment opportunity* means anything, tangible or intangible, that is offered, offered for sale, sold, or traded based wholly or in part on representations, either express or implied, about past, present, or future income, profit, or appreciation.

(t) *Material* means likely to affect a person's choice of, or conduct regarding, goods or services or a charitable contribution.

(u) *Merchant* means a person who is authorized under a written contract with an acquirer to honor or accept credit cards, or to transmit or process for payment credit card payments, for the purchase of goods or services or a charitable contribution.

(v) *Merchant agreement* means a written contract between a merchant and an acquirer to honor or accept credit cards, or to transmit or process for payment credit card payments, for the purchase of goods or services or a charitable contribution.

(w) *Negative option feature* means, in an offer or agreement to sell or provide any goods or services, a provision under which the customer's silence or failure to take an affirmative action to reject goods or services or to cancel the agreement is interpreted by the seller as acceptance of the offer.

(x) *Outbound telephone call* means a telephone call initiated by a telemarketer to induce the purchase of goods or services or to solicit a charitable contribution.

(y) *Person* means any individual, group, unincorporated association, limited or general partnership, corporation, or other business entity.

(z) *Preacquired account information* means any information that enables a seller or telemarketer to cause a charge to be placed against a customer's or donor's account without obtaining the account number directly from the customer or donor during the telemarketing transaction pursuant to which the account will be charged.

(aa) *Prize* means anything offered, or purportedly offered, and given, or purportedly given, to a person by chance. For purposes of this definition, chance exists if a person is guaranteed to receive an item and, at the time of the offer or purported offer, the telemarketer does not identify the specific item that the person will receive.

(bb) *Prize promotion* means:

(1) A sweepstakes or other game of chance; or

(2) An oral or written express or implied representation that a person has won, has been selected to receive, or may be eligible to receive a prize or purported prize.

(cc) *Remotely created payment order* means any payment instruction or order drawn on a person's account that is created by the payee or the payee's agent and deposited into or cleared through the check clearing system. The term includes, without limitation, a "remotely created check," as defined in Regulation CC, Availability of Funds and Collection of Checks, 12 CFR 229.2(ff), but does not include a payment order cleared through an Automated Clearinghouse (ACH) Network or subject to the Truth in Lending Act, 15 U.S.C. 1601 *et seq.*, and Regulation Z, 12 CFR part 1026.

(dd) *Seller* means any person who, in connection with a telemarketing transaction, provides, offers to provide, or arranges for others to provide goods or services to the customer in exchange for consideration.

(ee) *State* means any state of the United States, the District of Columbia, Puerto Rico, the Northern Mariana Islands, and any territory or possession of the United States.

(ff) *Telemarketer* means any person who, in connection with telemarketing, initiates or receives telephone calls to or from a customer or donor.

(gg) *Telemarketing* means a plan, program, or campaign which is conducted to induce the purchase of goods or services or a charitable contribution, by use of one or more telephones and which involves more than one interstate telephone call. The term does not include the solicitation of sales through the mailing of a catalog which: contains a written description or illustration of the goods or services offered for sale; includes the business address of the seller; includes multiple pages of written material or illustrations; and has been issued not less frequently than once a year, when the person making the solicitation does not solicit customers by telephone but only receives calls initiated by customers in response to the catalog and during those calls takes orders only without further solicitation. For purposes of the previous sentence, the term "further solicitation" does not include providing the customer with information about, or attempting to sell, any other item included in the same catalog which prompted the customer's call or in a substantially similar catalog.

(hh) *Upselling* means soliciting the purchase of goods or services following an initial transaction during a single telephone call. The upsell is a separate telemarketing transaction, not a continuation of the initial transaction. An "external upsell" is a solicitation made by or on behalf of a seller different from the seller in the initial transaction, regardless of whether the initial transaction and the subsequent solicitation are made by the same telemarketer. An "internal upsell" is a solicitation made by or on behalf of the same seller as in the initial transaction, regardless of whether the initial transaction and subsequent solicitation are made by the same telemarketer.

§310.3 Deceptive telemarketing acts or practices.

(a) *Prohibited deceptive telemarketing acts or practices.* It is a deceptive telemarketing act or practice and a violation of this Rule for any seller or telemarketer to engage in the following conduct:

(1) Before a customer consents to pay⁶⁵⁹ for goods or services offered, failing to disclose truthfully, in a clear and conspicuous manner, the following material information:

⁶⁵⁹ When a seller or telemarketer uses, or directs a customer to use, a courier to transport payment, the seller or telemarketer must make the disclosures required by §310.3(a)(1) before sending a courier to pick up payment or authorization for payment, or directing a customer to have a courier pick up payment or authorization for payment. In the case of debt relief services, the seller or telemarketer must make the disclosures required by §310.3(a)(1) before the consumer enrolls in an offered program.

(i) The total costs to purchase, receive, or use, and the quantity of, any goods or services that are the subject of the sales offer;⁶⁶⁰

⁶⁶⁰ For offers of consumer credit products subject to the Truth in Lending Act, 15 U.S.C. 1601 *et seq.*, and Regulation Z, 12 CFR 226, compliance with the disclosure requirements under the Truth in Lending Act and Regulation Z shall constitute compliance with §310.3(a)(1)(i) of this Rule.

(ii) All material restrictions, limitations, or conditions to purchase, receive, or use the goods or services that are the subject of the sales offer;

(iii) If the seller has a policy of not making refunds, cancellations, exchanges, or repurchases, a statement informing the customer that this is the seller's policy; or, if the seller or telemarketer makes a representation about a refund, cancellation, exchange, or repurchase policy, a statement of all material terms and conditions of such policy;

(iv) In any prize promotion, the odds of being able to receive the prize, and, if the odds are not calculable in advance, the factors used in calculating the odds; that no purchase or payment is required to win a prize or to participate in a prize promotion and that any purchase or payment will not increase the person's chances of winning; and the no-purchase/no-payment method of participating in the prize promotion with either instructions on how to participate or an address or local or toll-free telephone number to which customers may write or call for information on how to participate;

(v) All material costs or conditions to receive or redeem a prize that is the subject of the prize promotion;

(vi) In the sale of any goods or services represented to protect, insure, or otherwise limit a customer's liability in the event of unauthorized use of the customer's credit card, the limits on a cardholder's liability for unauthorized use of a credit card pursuant to 15 U.S.C. 1643;

(vii) If the offer includes a negative option feature, all material terms and conditions of the negative option feature, including, but not limited to, the fact that the customer's account will be charged unless the customer takes an affirmative action to avoid the charge(s), the date(s) the charge(s) will be submitted for payment, and the specific steps the customer must take to avoid the charge(s); and

(viii) In the sale of any debt relief service:

(A) the amount of time necessary to achieve the represented results, and to the extent that the service may include a settlement offer to any of the customer's creditors or debt collectors, the time by which the debt relief service provider will make a bona fide settlement offer to each of them;

(B) to the extent that the service may include a settlement offer to any of the customer's creditors or debt collectors, the amount of money or the percentage of each outstanding debt that the customer must accumulate before the debt relief service provider will make a bona fide settlement offer to each of them;

(C) to the extent that any aspect of the debt relief service relies upon or results in the customer's failure to make timely payments to creditors or debt collectors, that the use of the debt relief service will likely adversely affect the customer's creditworthiness, may result in the customer being subject to collections or sued by creditors or debt collectors, and may increase the amount of money the customer owes due to the accrual of fees and interest; and

(D) to the extent that the debt relief service requests or requires the customer to place funds in an account at an insured financial institution, that the customer owns the funds held in the account, the customer may withdraw from the debt relief service at any time without penalty, and, if the customer withdraws, the customer must receive all funds in the account, other than funds earned by the debt relief service in compliance with §310.4(a)(5)(i)(A) through (C).

(2) Misrepresenting, directly or by implication, in the sale of goods or services any of the following material information:

(i) The total costs to purchase, receive, or use, and the quantity of, any goods or services that are the subject of a sales offer;

(ii) Any material restriction, limitation, or condition to purchase, receive, or use goods or services that are the subject of a sales offer;

(iii) Any material aspect of the performance, efficacy, nature, or central characteristics of goods or services that are the subject of a sales offer;

(iv) Any material aspect of the nature or terms of the seller's refund, cancellation, exchange, or repurchase policies;

(v) Any material aspect of a prize promotion including, but not limited to, the odds of being able to receive a prize, the nature or value of a prize, or that a purchase or payment is required to win a prize or to participate in a prize promotion;

(vi) Any material aspect of an investment opportunity including, but not limited to, risk, liquidity, earnings potential, or profitability;

(vii) A seller's or telemarketer's affiliation with, or endorsement or sponsorship by, any person or government entity;

(viii) That any customer needs offered goods or services to provide protections a customer already has pursuant to 15 U.S.C. 1643;

(ix) Any material aspect of a negative option feature including, but not limited to, the fact that the customer's account will be charged unless the customer takes an affirmative action to avoid the charge(s), the date(s) the charge(s) will be submitted for payment, and the specific steps the customer must take to avoid the charge(s); or

(x) Any material aspect of any debt relief service, including, but not limited to, the amount of money or the percentage of the debt amount that a customer may save by using such service; the amount of time necessary to achieve the represented results; the amount of money or the percentage of each outstanding debt that the customer must accumulate before the provider of the debt relief service will initiate attempts with the customer's creditors or debt collectors or make a bona fide offer to negotiate, settle, or modify the terms of the customer's debt; the effect of the service on a customer's creditworthiness; the effect of the service on collection efforts of the customer's creditors or debt collectors; the percentage or number of customers who attain the represented results; and whether a debt relief service is offered or provided by a non-profit entity.

(3) Causing billing information to be submitted for payment, or collecting or attempting to collect payment for goods or services or a charitable contribution, directly or indirectly, without the customer's or donor's express verifiable authorization, except when the method of payment used is a credit card subject to protections of the Truth in Lending Act and Regulation Z,⁶⁶¹ or a debit card subject to the protections of the Electronic Fund Transfer Act and Regulation E.⁶⁶² Such authorization shall be deemed verifiable if any of the following means is employed:

⁶⁶¹ Truth in Lending Act, 15 U.S.C. 1601 *et seq.*, and Regulation Z, 12 CFR part 226.

⁶⁶² Electronic Fund Transfer Act, 15 U.S.C. 1693 *et seq.*, and Regulation E, 12 CFR part 205.

(i) Express written authorization by the customer or donor, which includes the customer's or donor's signature;⁶⁶³

⁶⁶³ For purposes of this Rule, the term "signature" shall include an electronic or digital form of signature, to the extent that such form of signature is recognized as a valid signature under applicable federal law or state contract law.

(ii) Express oral authorization which is audio-recorded and made available upon request to the customer or donor, and the customer's or donor's bank or other billing entity, and which evidences clearly both the customer's or donor's authorization of payment for the goods or services or charitable contribution that are the subject of the telemarketing transaction and the customer's or donor's receipt of all of the following information:

(A) An accurate description, clearly and conspicuously stated, of the goods or services or charitable contribution for which payment authorization is sought;

(B) The number of debits, charges, or payments (if more than one);

(C) The date(s) the debit(s), charge(s), or payment(s) will be submitted for payment;

(D) The amount(s) of the debit(s), charge(s), or payment(s);

(E) The customer's or donor's name;

(F) The customer's or donor's billing information, identified with sufficient specificity such that the customer or donor understands what account will be used to collect payment for the goods or services or charitable contribution that are the subject of the telemarketing transaction;

(G) A telephone number for customer or donor inquiry that is answered during normal business hours; and

(H) The date of the customer's or donor's oral authorization; or

(iii) Written confirmation of the transaction, identified in a clear and conspicuous manner as such on the outside of the envelope, sent to the customer or donor via first class mail prior to the submission for payment of the customer's or donor's billing information, and that includes all of the information contained in §§310.3(a)(3)(ii)(A)-(G) and a clear and conspicuous statement of the procedures by which the customer or donor can obtain a refund from the seller or telemarketer or charitable organization in the event the confirmation is inaccurate; provided, however, that this means of authorization shall not be deemed verifiable in instances in which goods or services are offered in a transaction involving a free-to-pay conversion and preacquired account information.

(4) Making a false or misleading statement to induce any person to pay for goods or services or to induce a charitable contribution.

(b) *Assisting and facilitating.* It is a deceptive telemarketing act or practice and a violation of this Rule for a person to provide substantial assistance or support to any seller or telemarketer when that person knows or consciously avoids knowing that the seller or telemarketer is engaged in any act or practice that violates §§310.3(a), (c) or (d), or §310.4 of this Rule.

(c) *Credit card laundering.* Except as expressly permitted by the applicable credit card system, it is a deceptive telemarketing act or practice and a violation of this Rule for:

(1) A merchant to present to or deposit into, or cause another to present to or deposit into, the credit card system for payment, a credit card sales draft generated by a telemarketing transaction that is not the result of a telemarketing credit card transaction between the cardholder and the merchant;

(2) Any person to employ, solicit, or otherwise cause a merchant, or an employee, representative, or agent of the merchant, to present to or deposit into the credit card system for payment, a credit card sales draft generated by a telemarketing transaction that is not the result of a telemarketing credit card transaction between the cardholder and the merchant; or

(3) Any person to obtain access to the credit card system through the use of a business relationship or an affiliation with a merchant, when such access is not authorized by the merchant agreement or the applicable credit card system.

(d) *Prohibited deceptive acts or practices in the solicitation of charitable contributions.* It is a fraudulent charitable solicitation, a deceptive telemarketing act or practice, and a violation of this Rule for any telemarketer soliciting charitable contributions to misrepresent, directly or by implication, any of the following material information:

(1) The nature, purpose, or mission of any entity on behalf of which a charitable contribution is being requested;

(2) That any charitable contribution is tax deductible in whole or in part;

(3) The purpose for which any charitable contribution will be used;

(4) The percentage or amount of any charitable contribution that will go to a charitable organization or to any particular charitable program;

(5) Any material aspect of a prize promotion including, but not limited to: the odds of being able to receive a prize; the nature or value of a prize; or that a charitable contribution is required to win a prize or to participate in a prize promotion; or

(6) A charitable organization's or telemarketer's affiliation with, or endorsement or sponsorship by, any person or government entity.

§310.4 Abusive telemarketing acts or practices.

(a) *Abusive conduct generally.* It is an abusive telemarketing act or practice and a violation of this Rule for any seller or telemarketer to engage in the following conduct:

(1) Threats, intimidation, or the use of profane or obscene language;

(2) Requesting or receiving payment of any fee or consideration for goods or services represented to remove derogatory information from, or improve, a person's credit history, credit record, or credit rating until:

(i) The time frame in which the seller has represented all of the goods or services will be provided to that person has expired; and

(ii) The seller has provided the person with documentation in the form of a consumer report from a consumer reporting agency demonstrating that the promised results have been achieved, such report having been issued more than six months after the results were achieved. Nothing in this Rule should be construed to affect the requirement in the Fair Credit Reporting Act, 15 U.S.C. 1681, that a consumer report may only be obtained for a specified permissible purpose;

(3) Requesting or receiving payment of any fee or consideration from a person for goods or services represented to recover or otherwise assist in the return of money or any other item of value paid for by, or promised to, that person in a previous transaction, until seven (7) business days after such money or other item is delivered to that person. This provision shall not apply to goods or services provided to a person by a licensed attorney;

(4) Requesting or receiving payment of any fee or consideration in advance of obtaining a loan or other extension of credit when the seller or telemarketer has guaranteed or represented a high likelihood of success in obtaining or arranging a loan or

other extension of credit for a person;

(5)(i) Requesting or receiving payment of any fee or consideration for any debt relief service until and unless:

(A) The seller or telemarketer has renegotiated, settled, reduced, or otherwise altered the terms of at least one debt pursuant to a settlement agreement, debt management plan, or other such valid contractual agreement executed by the customer;

(B) The customer has made at least one payment pursuant to that settlement agreement, debt management plan, or other valid contractual agreement between the customer and the creditor or debt collector; and

(C) To the extent that debts enrolled in a service are renegotiated, settled, reduced, or otherwise altered individually, the fee or consideration either:

(1) Bears the same proportional relationship to the total fee for renegotiating, settling, reducing, or altering the terms of the entire debt balance as the individual debt amount bears to the entire debt amount. The individual debt amount and the entire debt amount are those owed at the time the debt was enrolled in the service; or

(2) Is a percentage of the amount saved as a result of the renegotiation, settlement, reduction, or alteration. The percentage charged cannot change from one individual debt to another. The amount saved is the difference between the amount owed at the time the debt was enrolled in the service and the amount actually paid to satisfy the debt.

(ii) Nothing in §310.4(a)(5)(i) prohibits requesting or requiring the customer to place funds in an account to be used for the debt relief provider's fees and for payments to creditors or debt collectors in connection with the renegotiation, settlement, reduction, or other alteration of the terms of payment or other terms of a debt, provided that:

(A) The funds are held in an account at an insured financial institution;

(B) The customer owns the funds held in the account and is paid accrued interest on the account, if any;

(C) The entity administering the account is not owned or controlled by, or in any way affiliated with, the debt relief service;

(D) The entity administering the account does not give or accept any money or other compensation in exchange for referrals of business involving the debt relief service; and

(E) The customer may withdraw from the debt relief service at any time without penalty, and must receive all funds in the account, other than funds earned by the debt relief service in compliance with §310.4(a)(5)(i)(A) through (C), within seven (7) business days of the customer's request.

(6) Disclosing or receiving, for consideration, unencrypted consumer account numbers for use in telemarketing; provided, however, that this paragraph shall not apply to the disclosure or receipt of a customer's or donor's billing information to process a payment for goods or services or a charitable contribution pursuant to a transaction;

(7) Causing billing information to be submitted for payment, directly or indirectly, without the express informed consent of the customer or donor. In any telemarketing transaction, the seller or telemarketer must obtain the express informed consent of the customer or donor to be charged for the goods or services or charitable contribution and to be charged using the identified account. In any telemarketing transaction involving preacquired account information, the requirements in paragraphs (a)(7)(i) through (ii) of this section must be met to evidence express informed consent.

(i) In any telemarketing transaction involving preacquired account information and a free-to-pay conversion feature, the seller or telemarketer must:

(A) Obtain from the customer, at a minimum, the last four (4) digits of the account number to be charged;

(B) Obtain from the customer his or her express agreement to be charged for the goods or services and to be charged using the account number pursuant to paragraph (a)(7)(i)(A) of this section; and,

(C) Make and maintain an audio recording of the entire telemarketing transaction.

(ii) In any other telemarketing transaction involving preacquired account information not described in paragraph (a)(7)(i) of this section, the seller or telemarketer must:

(A) At a minimum, identify the account to be charged with sufficient specificity for the customer or donor to understand what account will be charged; and

(B) Obtain from the customer or donor his or her express agreement to be charged for the goods or services and to be charged using the account number identified pursuant to paragraph (a)(7)(ii)(A) of this section;

(8) Failing to transmit or cause to be transmitted the telephone number, and, when made available by the telemarketer's carrier, the name of the telemarketer, to any caller identification service in use by a recipient of a telemarketing call; provided that it shall not be a violation to substitute (for the name and phone number used in, or billed for, making the call) the name of the seller or charitable organization on behalf of which a telemarketing call is placed, and the seller's or charitable organization's customer or donor service telephone number, which is answered during regular business hours;

(9) Creating or causing to be created, directly or indirectly, a remotely created payment order as payment for goods or services offered or sold through telemarketing or as a charitable contribution solicited or sought through telemarketing; or

(10) Accepting from a customer or donor, directly or indirectly, a cash-to-cash money transfer or cash reload mechanism as payment for goods or services offered or sold through telemarketing or as a charitable contribution solicited or sought through telemarketing.

(b) *Pattern of calls.* (1) It is an abusive telemarketing act or practice and a violation of this Rule for a telemarketer to engage in, or for a seller to cause a telemarketer to engage in, the following conduct:

(i) Causing any telephone to ring, or engaging any person in telephone conversation, repeatedly or continuously with intent to annoy, abuse, or harass any person at the called number;

(ii) Denying or interfering in any way, directly or indirectly, with a person's right to be placed on any registry of names and/or telephone numbers of persons who do not wish to receive outbound telephone calls established to comply with paragraph (b)(1)(iii)(A) of this section, including, but not limited to, harassing any person who makes such a request; hanging up on that person; failing to honor the request; requiring the person to listen to a sales pitch before accepting the request; assessing a charge or fee for honoring the request; requiring a person to call a different number to submit the request; and requiring the person to identify the seller making the call or on whose behalf the call is made;

(iii) Initiating any outbound telephone call to a person when:

(A) That person previously has stated that he or she does not wish to receive an outbound telephone call made by or on behalf of the seller whose goods or services are being offered or made on behalf of the charitable organization for which a charitable contribution is being solicited; or

(B) That person's telephone number is on the "do-not-call" registry, maintained by the Commission, of persons who do not wish to receive outbound telephone calls to induce the purchase of goods or services unless the seller or telemarketer:

(1) Can demonstrate that the seller has obtained the express agreement, in writing, of such person to place calls to that person. Such written agreement shall clearly evidence such person's authorization that calls made by or on behalf of a specific party may be placed to that person, and shall include the telephone number to which the calls may be placed and the signature⁶⁶⁴ of that person; or

⁶⁶⁴For purposes of this Rule, the term "signature" shall include an electronic or digital form of signature, to the extent that such form of signature is recognized as a valid signature under applicable federal law or state contract law.

(2) Can demonstrate that the seller has an established business relationship with such person, and that person has not stated that he or she does not wish to receive outbound telephone calls under paragraph (b)(1)(iii)(A) of this section; or

(iv) Abandoning any outbound telephone call. An outbound telephone call is "abandoned" under this section if a person answers it and the telemarketer does not connect the call to a sales representative within two (2) seconds of the person's completed greeting.

(v) Initiating any outbound telephone call that delivers a prerecorded message, other than a prerecorded message permitted for compliance with the call abandonment safe harbor in §310.4(b)(4)(iii), unless:

(A) In any such call to induce the purchase of any good or service, the seller has obtained from the recipient of the call an express agreement, in writing, that:

(i) The seller obtained only after a clear and conspicuous disclosure that the purpose of the agreement is to authorize the seller to place prerecorded calls to such person;

(ii) The seller obtained without requiring, directly or indirectly, that the agreement be executed as a condition of purchasing any good or service;

(iii) Evidences the willingness of the recipient of the call to receive calls that deliver prerecorded messages by or on behalf of a specific seller; and

(iv) Includes such person's telephone number and signature;⁶⁶⁵ and

⁶⁶⁵ For purposes of this Rule, the term "signature" shall include an electronic or digital form of signature, to the extent that such form of signature is recognized as a valid signature under applicable federal law or state contract law.

(B) In any such call to induce the purchase of any good or service, or to induce a charitable contribution from a member of, or previous donor to, a non-profit charitable organization on whose behalf the call is made, the seller or telemarketer:

(i) Allows the telephone to ring for at least fifteen (15) seconds or four (4) rings before disconnecting an unanswered call; and

(ii) Within two (2) seconds after the completed greeting of the person called, plays a prerecorded message that promptly provides the disclosures required by §310.4(d) or (e), followed immediately by a disclosure of one or both of the following:

(A) In the case of a call that could be answered in person by a consumer, that the person called can use an automated interactive voice and/or keypress-activated opt-out mechanism to assert a Do Not Call request pursuant to §310.4(b)(1)(iii)(A) at any time during the message. The mechanism must:

(1) Automatically add the number called to the seller's entity-specific Do Not Call list;

(2) Once invoked, immediately disconnect the call; and

(3) Be available for use at any time during the message; and

(B) In the case of a call that could be answered by an answering machine or voicemail service, that the person called can use a toll-free telephone number to assert a Do Not Call request pursuant to §310.4(b)(1)(iii)(A). The number provided must connect directly to an automated interactive voice or keypress-activated opt-out mechanism that:

(1) Automatically adds the number called to the seller's entity-specific Do Not Call list;

(2) Immediately thereafter disconnects the call; and

(3) Is accessible at any time throughout the duration of the telemarketing campaign; and

(iii) Complies with all other requirements of this part and other applicable federal and state laws.

(C) Any call that complies with all applicable requirements of this paragraph (v) shall not be deemed to violate §310.4(b)(1)(iv) of this part.

(D) This paragraph (v) shall not apply to any outbound telephone call that delivers a prerecorded healthcare message made by, or on behalf of, a covered entity or its business associate, as those terms are defined in the HIPAA Privacy Rule, 45 CFR 160.103.

(2) It is an abusive telemarketing act or practice and a violation of this Rule for any person to sell, rent, lease, purchase, or use any list established to comply with §310.4(b)(1)(iii)(A), or maintained by the Commission pursuant to §310.4(b)(1)(iii)(B), for any purpose except compliance with the provisions of this Rule or otherwise to prevent telephone calls to telephone numbers on such lists.

(3) A seller or telemarketer will not be liable for violating §310.4(b)(1)(ii) and (iii) if it can demonstrate that, as part of the seller's or telemarketer's routine business practice:

(i) It has established and implemented written procedures to comply with §310.4(b)(1)(ii) and (iii);

(ii) It has trained its personnel, and any entity assisting in its compliance, in the procedures established pursuant to §310.4(b)(3)(i);

(iii) The seller, or a telemarketer or another person acting on behalf of the seller or charitable organization, has maintained and recorded a list of telephone numbers the seller or charitable organization may not contact, in compliance with §310.4(b)(1)(iii)(A);

(iv) The seller or a telemarketer uses a process to prevent telemarketing to any telephone number on any list established pursuant to §310.4(b)(3)(iii) or 310.4(b)(1)(iii)(B), employing a version of the "do-not-call" registry obtained from the Commission no more than thirty-one (31) days prior to the date any call is made, and maintains records documenting this process;

(v) The seller or a telemarketer or another person acting on behalf of the seller or charitable organization, monitors and enforces compliance with the procedures established pursuant to §310.4(b)(3)(i); and

(vi) Any subsequent call otherwise violating paragraph (b)(1)(ii) or (iii) of this section is the result of error and not of failure to obtain any information necessary to comply with a request pursuant to paragraph (b)(1)(iii)(A) of this section not to receive further calls by or on behalf of a seller or charitable organization.

(4) A seller or telemarketer will not be liable for violating §310.4(b)(1)(iv) if:

(i) The seller or telemarketer employs technology that ensures abandonment of no more than three (3) percent of all calls answered by a person, measured over the duration of a single calling campaign, if less than 30 days, or separately over each successive 30-day period or portion thereof that the campaign continues.

(ii) The seller or telemarketer, for each telemarketing call placed, allows the telephone to ring for at least fifteen (15) seconds or four (4) rings before disconnecting an unanswered call;

(iii) Whenever a sales representative is not available to speak with the person answering the call within two (2) seconds after the person's completed greeting, the seller or telemarketer promptly plays a recorded message that states the name and telephone number of the seller on whose behalf the call was placed⁶⁶⁶; and

⁶⁶⁶ This provision does not affect any seller's or telemarketer's obligation to comply with relevant state and federal laws, including but not limited to the TCPA, 47 U.S.C. 227, and 47 CFR part 64.1200.

(iv) The seller or telemarketer, in accordance with §310.5(b)-(d), retains records establishing compliance with §310.4(b)(4)(i)-(iii).

(c) *Calling time restrictions.* Without the prior consent of a person, it is an abusive telemarketing act or practice and a violation of this Rule for a telemarketer to engage in outbound telephone calls to a person's residence at any time other than between 8:00 a.m. and 9:00 p.m. local time at the called person's location.

(d) *Required oral disclosures in the sale of goods or services.* It is an abusive telemarketing act or practice and a violation of this Rule for a telemarketer in an outbound telephone call or internal or external upsell to induce the purchase of goods or services to fail to disclose truthfully, promptly, and in a clear and conspicuous manner to the person receiving the call, the following information:

(1) The identity of the seller;

(2) That the purpose of the call is to sell goods or services;

(3) The nature of the goods or services; and

(4) That no purchase or payment is necessary to be able to win a prize or participate in a prize promotion if a prize promotion is offered and that any purchase or payment will not increase the person's chances of winning. This disclosure must be made before or in conjunction with the description of the prize to the person called. If requested by that person, the telemarketer must disclose the no-purchase/no-payment entry method for the prize promotion; provided, however, that, in any internal upsell for the sale of goods or services, the seller or telemarketer must provide the disclosures listed in this section only to the extent that the information in the upsell differs from the disclosures provided in the initial telemarketing transaction.

(e) *Required oral disclosures in charitable solicitations.* It is an abusive telemarketing act or practice and a violation of this Rule for a telemarketer, in an outbound telephone call to induce a charitable contribution, to fail to disclose truthfully, promptly, and in a clear and conspicuous manner to the person receiving the call, the following information:

(1) The identity of the charitable organization on behalf of which the request is being made; and

(2) That the purpose of the call is to solicit a charitable contribution.

§310.5 Recordkeeping requirements.

(a) Any seller or telemarketer shall keep, for a period of 24 months from the date the record is produced, the following records relating to its telemarketing activities:

(1) All substantially different advertising, brochures, telemarketing scripts, and promotional materials;

(2) The name and last known address of each prize recipient and the prize awarded for prizes that are represented, directly or by implication, to have a value of \$25.00 or more;

(3) The name and last known address of each customer, the goods or services purchased, the date such goods or services were shipped or provided, and the amount paid by the customer for the goods or services;⁶⁶⁷

⁶⁶⁷ For offers of consumer credit products subject to the Truth in Lending Act, 15 U.S.C. 1601 *et seq.*, and Regulation Z, 12 CFR 226, compliance with the recordkeeping requirements under the Truth in Lending Act, and Regulation Z, shall constitute compliance with §310.5(a)(3) of this Rule.

(4) The name, any fictitious name used, the last known home address and telephone number, and the job title(s) for all current and former employees directly involved in telephone sales or solicitations; provided, however, that if the seller or telemarketer permits fictitious names to be used by employees, each fictitious name must be traceable to only one specific employee; and

(5) All verifiable authorizations or records of express informed consent or express agreement required to be provided or received under this Rule.

(b) A seller or telemarketer may keep the records required by §310.5(a) in any form, and in the same manner, format, or place as they keep such records in the ordinary course of business. Failure to keep all records required by §310.5(a) shall be a violation of this Rule.

(c) The seller and the telemarketer calling on behalf of the seller may, by written agreement, allocate responsibility between themselves for the recordkeeping required by this Section. When a seller and telemarketer have entered into such an agreement, the terms of that agreement shall govern, and the seller or telemarketer, as the case may be, need not keep records that duplicate those of the other. If the agreement is unclear as to who must maintain any required record(s), or if no such agreement exists, the seller shall be responsible for complying with §§310.5(a)(1)-(3) and (5); the telemarketer shall be responsible for complying with §310.5(a)(4).

(d) In the event of any dissolution or termination of the seller's or telemarketer's business, the principal of that seller or telemarketer shall maintain all records as required under this section. In the event of any sale, assignment, or other change in ownership of the seller's or telemarketer's business, the successor business shall maintain all records required under this section.

§310.6 Exemptions.

(a) Solicitations to induce charitable contributions via outbound telephone calls are not covered by §310.4(b)(1)(iii)(B) of this Rule.

(b) The following acts or practices are exempt from this Rule:

(1) The sale of pay-per-call services subject to the Commission's Rule entitled "Trade Regulation Rule Pursuant to the Telephone Disclosure and Dispute Resolution Act of 1992," 16 CFR part 308, *provided*, however, that this exemption does not apply to the requirements of §§310.4(a)(1), (a)(7), (b), and (c);

(2) The sale of franchises subject to the Commission's Rule entitled "Disclosure Requirements and Prohibitions Concerning Franchising," ("Franchise Rule") 16 CFR part 436, and the sale of business opportunities subject to the Commission's Rule entitled "Disclosure Requirements and Prohibitions Concerning Business Opportunities," ("Business Opportunity Rule") 16 CFR part 437, *provided*, however, that this exemption does not apply to the requirements of §§310.4(a)(1), (a)(7), (b), and (c);

(3) Telephone calls in which the sale of goods or services or charitable solicitation is not completed, and payment or authorization of payment is not required, until after a face-to-face sales or donation presentation by the seller or charitable organization, *provided*, however, that this exemption does not apply to the requirements of §§310.4(a)(1), (a)(7), (b), and (c);

(4) Telephone calls initiated by a customer or donor that are not the result of any solicitation by a seller, charitable organization, or telemarketer, *provided*, however, that this exemption does not apply to any instances of upselling included in such telephone calls;

(5) Telephone calls initiated by a customer or donor in response to an advertisement through any medium, other than direct mail solicitation, *provided*, however, that this exemption does not apply to:

(i) Calls initiated by a customer or donor in response to an advertisement relating to investment opportunities, debt relief services, business opportunities other than business arrangements covered by the Franchise Rule or Business Opportunity Rule, or advertisements involving offers for goods or services described in §310.3(a)(1)(vi) or §310.4(a)(2) through (4);

- (ii) The requirements of §310.4(a)(9) or (10); or
- (iii) Any instances of upselling included in such telephone calls;

(6) Telephone calls initiated by a customer or donor in response to a direct mail solicitation, including solicitations via the U.S. Postal Service, facsimile transmission, electronic mail, and other similar methods of delivery in which a solicitation is directed to specific address(es) or person(s), that clearly, conspicuously, and truthfully discloses all material information listed in §310.3(a)(1), for any goods or services offered in the direct mail solicitation, and that contains no material misrepresentation regarding any item contained in §310.3(d) for any requested charitable contribution; *provided*, however, that this exemption does not apply to:

(i) Calls initiated by a customer in response to a direct mail solicitation relating to prize promotions, investment opportunities, debt relief services, business opportunities other than business arrangements covered by the Franchise Rule or Business Opportunity Rule, or goods or services described in §310.3(a)(1)(vi) or §310.4(a)(2) through (4);

- (ii) The requirements of §310.4(a)(9) or (10); or
- (iii) Any instances of upselling included in such telephone calls; and

(7) Telephone calls between a telemarketer and any business to induce the purchase of goods or services or a charitable contribution by the business, except calls to induce the retail sale of nondurable office or cleaning supplies; *provided*, however, that §§310.4(b)(1)(iii)(B) and 310.5 shall not apply to sellers or telemarketers of nondurable office or cleaning supplies.

§310.7 Actions by states and private persons.

(a) Any attorney general or other officer of a state authorized by the state to bring an action under the Telemarketing and Consumer Fraud and Abuse Prevention Act, and any private person who brings an action under that Act, shall serve written notice of its action on the Commission, if feasible, prior to its initiating an action under this Rule. The notice shall be sent to the Office of the Director, Bureau of Consumer Protection, Federal Trade Commission, Washington, DC 20580, and shall include a copy of the state's or private person's complaint and any other pleadings to be filed with the court. If prior notice is not feasible, the state or private person shall serve the Commission with the required notice immediately upon instituting its action.

(b) Nothing contained in this Section shall prohibit any attorney general or other authorized state official from proceeding in state court on the basis of an alleged violation of any civil or criminal statute of such state.

§310.8 Fee for access to the National Do Not Call Registry.

(a) It is a violation of this Rule for any seller to initiate, or cause any telemarketer to initiate, an outbound telephone call to any person whose telephone number is within a given area code unless such seller, either directly or through another person, first has paid the annual fee, required by §310.8(c), for access to telephone numbers within that area code that are included in the National Do Not Call Registry maintained by the Commission under §310.4(b)(1)(iii)(B); *provided*, however, that such payment is not necessary if the seller initiates, or causes a telemarketer to initiate, calls solely to persons pursuant to §§310.4(b)(1)(iii)(B)(i) or (ii), and the seller does not access the National Do Not Call Registry for any other purpose.

(b) It is a violation of this Rule for any telemarketer, on behalf of any seller, to initiate an outbound telephone call to any person whose telephone number is within a given area code unless that seller, either directly or through another person, first has paid the annual fee, required by §310.8(c), for access to the telephone numbers within that area code that are included in the National Do Not Call Registry; *provided*, however, that such payment is not necessary if the seller initiates, or causes a telemarketer to initiate, calls solely to persons pursuant to §§310.4(b)(1)(iii)(B)(i) or (ii), and the seller does not access the National Do Not Call Registry for any other purpose.

(c) The annual fee, which must be paid by any person prior to obtaining access to the National Do Not Call Registry, is \$65 for each area code of data accessed, up to a maximum of \$17,765; *provided*, however, that there shall be no charge to any person for accessing the first five area codes of data, and *provided further*, that there shall be no charge to any person engaging in or causing others to engage in outbound telephone calls to consumers and who is accessing area codes of data in the National Do Not Call Registry if the person is permitted to access, but is not required to access, the National Do Not Call Registry under this Rule, 47 CFR 64.1200, or any other Federal regulation or law. No person may participate in any arrangement to share the cost of accessing the National Do Not Call Registry, including any arrangement with any telemarketer or service provider to divide the costs to access the registry among various clients of that telemarketer or service provider.

(d) Each person who pays, either directly or through another person, the annual fee set forth in paragraph (c) of this section, each person excepted under paragraph (c) from paying the annual fee, and each person excepted from paying an annual fee under §310.4(b)(1)(iii)(B), will be provided a unique account number that will allow that person to access the registry data for the selected area codes at any time for the twelve month period beginning on the first day of the month in which the person paid the fee (“the annual period”). To obtain access to additional area codes of data during the first six months of the annual period, each person required to pay the fee under paragraph (c) of this section must first pay \$65 for each additional area code of data not initially selected. To obtain access to additional area codes of data during the second six months of the annual period, each person required to pay the fee under paragraph (c) of this section must first pay \$32 for each additional area code of data not initially selected. The payment of the additional fee will permit the person to access the additional area codes of data for the remainder of the annual period.

(e) Access to the National Do Not Call Registry is limited to telemarketers, sellers, others engaged in or causing others to engage in telephone calls to consumers, service providers acting on behalf of such persons, and any government agency that has law enforcement authority. Prior to accessing the National Do Not Call Registry, a person must provide the identifying information required by the operator of the registry to collect the fee, and must certify, under penalty of law, that the person is accessing the registry solely to comply with the provisions of this Rule or to otherwise prevent telephone calls to telephone numbers on the registry. If the person is accessing the registry on behalf of sellers, that person also must identify each of the sellers on whose behalf it is accessing the registry, must provide each seller's unique account number for access to the national registry, and must certify, under penalty of law, that the sellers will be using the information gathered from the registry solely to comply with the provisions of this Rule or otherwise to prevent telephone calls to telephone numbers on the registry.

Dear Student Loan Borrower:

We're writing to you because you paid SLAC, Inc., Navloan, or Aspyre to help you reduce your student loan payments, apply for forbearance or enter into a forgiveness program offered by the U.S. Department of Education. The Federal Trade Commission recently filed a lawsuit against us. In it, the FTC claims that in some instances we misled customers into believing we would help them lower their student loan payments. The FTC also claims that we misled some customers when we told them they would get loan forgiveness and wouldn't have to pay off their student loans. We have settled the lawsuit with the FTC where we neither admit nor deny these claims.

We've agreed to stop billing you and stop providing our services unless you tell us you want to keep using our services.

If you do NOT want to keep using our services, you do not have to do anything. If you stop using our services, we recommend that you contact the Department of Education or your student loan servicer to do the following:

- **Verify your contact information.** That way, they can contact you about your loan, if necessary.
- **Find out when you must re-certify your income and household size.** Your loan payments are based on your income and household size. Your loan servicer must re-certify that information every year to re-enroll you in the payment plan. If you don't re-certify your information your monthly payments could go up.

If you have questions about your loan repayment options, ask the Department of Education or your loan servicer.

If you don't have the contact information for your loan servicer, you can find it at [StudentAid.gov/servicer](https://studentaid.gov/servicer). You can call the Department of Education at 1-800-557-7394 or visit [StudentAid.gov/repay](https://studentaid.gov/repay) to learn about your options.

If you DO want to keep using our services, you must notify us within 30 days of receiving this letter. If you choose to keep using our services, we will resume collecting payments after we

get your notification. You can tell us that you want to keep using our services by doing one of the following:
