24	Plaintiff, the Federal Trade Commission ("FTC"), for its Complaint alleges:			
25	1. The FTC brings this action under Sections 13(b) and 19 of the Federal Trade			
26	Commission Act ("FTC Act"), 15 U.S.C. §§ 53(b), 57b, and the Telemarketing and Consumer			
27	Fraud and Abuse Prevention Act ("Telemarketing Ac	et"), 15 U.S.C. §§ 6101-6108, to obtain		
28				

permanent injunctive relief, rescission or reformation of contracts, restitution, the refund of monies paid, disgorgement of ill-gotten monies, and other equitable relief for Defendants' acts or practices in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a), 52, and the FTC's Telemarketing Sales Rule ("TSR"), 16 C.F.R. Part 310, in connection with the advertising, marketing, promotion, offering for sale, or sale of Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem.

JURISDICTION AND VENUE

- 2. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331, 1337(a), and 1345.
- 3. Venue is proper in this District under 28 U.S.C. § 1391(b)(1), (b)(2), (c)(1), and (c)(2), and 15 U.S.C. § 53(b).

PLAINTIFF

- 4. The FTC is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The FTC enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The FTC also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce, and the TSR, which prohibits deceptive and abusive telemarketing acts or practices.
- 5. The FTC is authorized to initiate federal district court proceedings, by its own attorneys, to enjoin violations of the FTC Act and the TSR, and to secure such equitable relief as may be appropriate in each case, including rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies. 15 U.S.C. §§ 53(b), 57b, 15 U.S.C. §§ 6102(c) and 6105(b).

DEFENDANTS

- 6. Defendant Health Center, Inc. ("HCI") is a Nevada corporation with its principal place of business at 2310 Paseo del Prado, Suite A-205, Las Vegas, Nevada 89102. HCI transacts or has transacted business in this District and throughout the United States. At all times material to this Complaint, acting alone or in concert with others, HCI has advertised, marketed, distributed, or sold Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem to consumers throughout the United States.
- 7. Defendant Peggy Pearce is the owner, president, secretary, treasurer, and director of HCI. At all times material to this Complaint, acting alone or in concert with others, she has formulated, directed, controlled, had the authority to control, or participated in the acts and practices of HCI, including the acts and practices set forth in this Complaint. Defendant Pearce has had final approval over all aspects of the business, including advertising and billing, and has been heavily involved in HCI's day-to-day operations. Defendant Pearce has drafted telemarketing scripts, product packaging information, and product labels for HCI's products. Defendant Pearce is also the co-inventor of the Rejuvi-Stem formula. Defendant Pearce resides in this District and, in connection with the matters alleged herein, transacts or has transacted business in this District and throughout the United States.

COMMERCE

8. At all times material to this Complaint, Defendants have maintained a substantial course of trade in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

THE TELEMARKETING SALES RULE

9. In 1994, Congress directed the FTC to prescribe rules prohibiting abusive and deceptive telemarketing acts or practices pursuant to the Telemarketing Act, 15 U.S.C. §§

6101-6108. The FTC adopted the original TSR in 1995, extensively amended it in 2003, and amended certain provisions thereafter. 16 C.F.R. Part 310.

- 10. Under the TSR, a "telemarketer" means any person who, in connection with telemarketing, initiates or receives telephone calls to or from a customer. 16 C.F.R. § 310.2(ff). A "seller" means any person who, in connection with a telemarketing transaction, provides, offers to provide, or arranges for others to provide goods or services to the customer in exchange for consideration. *Id.* § 310.2(dd).
- 11. The TSR prohibits sellers and telemarketers from misrepresenting, directly or by implication, in the sale of goods or services, any material aspect of the performance, efficacy, nature, or central characteristics of the goods or services that are the subject of a sales offer. 16 C.F.R. § 310.3(a)(2)(iii). It also prohibits sellers and telemarketers from making a false or misleading statement to induce any person to pay for goods or services. 16 C.F.R. § 310.3(a)(4).
- 12. Pursuant to Section 3(c) of the Telemarketing Act, 15 U.S.C. § 6102(c), and Section 18(d)(3) of the FTC Act, 15 U.S.C. § 57a(d)(3), a violation of the TSR constitutes an unfair or deceptive act or practice in or affecting commerce, in violation of Section 5(a) of the FTC Act, 15 U.S.C. § 45(a).

DEFENDANTS' BUSINESS ACTIVITIES

13. Since at least January 1, 2015, Defendants have advertised, labeled, offered for sale, sold, or distributed health products, including, but not limited to, Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem to consumers throughout the United States through telemarketing sales calls, social media pages, and the following internet websites: rejuvi-cell.com, healthcenterinc.net, rejuvi-stem.com, and buyhci.com. Defendants have targeted the elderly in their advertising.

- 14. Rejuvi-Cell is a sublingual spray that purportedly contains homeopathic-level dilutions of the following active ingredients: somatotrophin, colostrum with IGF, pineal gland, pituitary gland, thyroid, kidney, adipose tissue, pancreas, adrenal gland, parathyroid, and hypothalamus. A product information sheet included with each Rejuvi-Cell shipment has directed consumers to apply fifteen sprays per day during the first week, twelve sprays per day during the second week, and nine sprays per day thereafter.
- 15. Rejuvi-Sea, which is sold in sixty-caplet bottles, purportedly contains marine phytoplankton with spirulina blue-green algae. Defendants have advised consumers to take two caplets daily.
- 16. Rejuvi-Stem is purportedly a "stem cell recruiter" tablet that enhances, releases, and recruits adult stem cells so that they can migrate to the parts of the body where they are needed the most. According to the product label, it contains Vitamin D-3 and "Plurinol," a proprietary blend of beta-glucan, astragalus extract, resveratrol, pomegranate peel, green tea, goji berry, aphanizomenon flos-aquae, probiotics, beet juice, and liposomes. It has been sold in sixty-tablet bottles, and each serving size is two tablets.
- 17. Defendants have sold each product in three- or twelve-bottle packs priced at \$349.95 plus shipping and \$799 plus shipping, respectively. Sales of the three products in the United States from January 2015 through July 2019, minus refunds, totaled approximately \$8.28 million.
- 18. Defendants have represented, among other things, through express and implied claims and consumer testimonials, that their products treat, mitigate, or cure a myriad of diseases and health conditions.
- 19. To induce consumers to purchase Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem,
 Defendants have disseminated or caused to be disseminated advertisements via internet websites,
 social media pages, and product packaging, including but not limited to, the attached Exhibits A

through J. Defendants have often contacted consumers initially through unsolicited telemarketing calls made by their employees or contractors, and thus are "telemarketers" and "sellers" engaged in "telemarketing" as defined by the TSR, 16 C.F.R. § 310.2(dd), (ff), and (gg). Defendants have placed the calls to consumers and have instructed their employees and contractors to follow word-for-word the telemarketing scripts attached as Exhibits C, G, and J. Defendants' advertisements have contained the following statements and depictions, among others:



- 22. Defendants engaged in their unlawful acts and practices repeatedly and unabated over a period of at least four years and continued their unlawful conduct despite having knowledge of numerous complaints. Defendants' unlawful acts and practices were the subject of a September 2016 law enforcement action by the Iowa Attorney General, yet Defendants continued to engage in such practices until August 31, 2019, more than a year after being notified of the FTC's investigation. Based on the facts and violations of law alleged in this Complaint, the FTC has reason to believe that Defendants are violating or are about to violate laws enforced by the Commission.

VIOLATIONS OF THE FTC ACT

- 23. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits "unfair or deceptive acts or practices in or affecting commerce."
- Misrepresentations or deceptive omissions of material fact constitute deceptive 24. acts or practices prohibited by Section 5(a) of the FTC Act.
- 25. Section 12 of the FTC Act, 15 U.S.C. § 52, prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, 15 U.S.C. § 52, Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem are either "foods" or "drugs" as defined in Section 15(b) and (c) of the FTC Act, 15 U.S.C. §§ 55(b), (c).

COUNT ONE

False or Unsubstantiated Efficacy Claims

- 26. In numerous instances in connection with the advertising, marketing, promotion, offering for sale, or sale of Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem, including through the means described in Paragraph 19, Defendants have represented, directly or indirectly, expressly or by implication, that:
- A. Rejuvi-Cell improves memory by 62%, causes weight and fat loss, including fat loss of 72%, and causes wrinkles to disappear by 51%;
- B. Rejuvi-Cell treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, Alzheimer's disease, fibromyalgia, arthritis, emphysema, asthma, muscular dystrophy, erectile dysfunction, obesity, high blood pressure, and high cholesterol;
- C. Rejuvi-Sea treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, dementia, Alzheimer's disease, Parkinson's disease, kidney disorders, autoimmune disorders, heart attacks, heart disease, atherosclerosis, strokes, liver disease, hepatitis, thyroid disorders, asthma, respiratory disorders, arthritis, rheumatoid arthritis, osteoporosis, joint pain, depression, chronic fatigue syndrome, obesity, high blood pressure, and high cholesterol; and
- D. Rejuvi-Stem treats, mitigates, or cures multiple diseases and health conditions, including pulmonary disease, heart disease, diabetes, memory loss, bone disease, arthritis, pain, and high blood pressure.
- 27. The representations set forth in Paragraph 26 are false or misleading or were not substantiated at the time the representations were made.

28. Therefore, the making of the representations as set forth in Paragraph 26 of this Complaint constitutes a deceptive act or practice and the making of false advertisements in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a), 52.

COUNT TWO

False Claims about Tests and Ingredient

- 29. In numerous instances in connection with the advertising, marketing, promotion, offering for sale, or sale of Rejuvi-Cell and Rejuvi-Sea, including through the means described in Paragraph 19 of this Complaint, Defendants have represented, directly or indirectly, expressly or by implication, that:
- A. Clinical studies show that Rejuvi-Cell improves memory by 62%, causes weight loss and fat loss, including fat loss of 72%, and causes wrinkles to disappear by 51%;

- C. Rejuvi-Cell contains human somatotrophin, also known as human growth hormone (HGH); and
- D. Research shows that Rejuvi-Sea treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, dementia, Alzheimer's disease, Parkinson's disease, kidney disorders, autoimmune disorders, heart disease, atherosclerosis, liver disease, hepatitis, thyroid disorders, asthma, respiratory disorders, rheumatoid arthritis, osteoporosis, joint pain depression, and chronic fatigue syndrome.
 - 30. In truth and in fact:
- A. Clinical studies do not show that Rejuvi-Cell improves memory by 62%, causes weight and fat loss, including fat loss of 72%, or causes wrinkles to disappear by 51%;

- B. Clinical studies do not show that Rejuvi-Cell treats, mitigates, or cures Alzheimer's disease, fibromyalgia, arthritis, emphysema, asthma, muscular dystrophy, erectile dysfunction, obesity, high blood pressure, or high cholesterol;
- C. Rejuvi-Cell does not contain human somatotrophin, also known as human growth hormone (HGH), but rather contains porcine (pig) somatotrophin; and
- D. Research does not show that Rejuvi-Sea treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, dementia, Alzheimer's disease, Parkinson's disease, kidney disorders, autoimmune disorders, heart disease, atherosclerosis, liver disease, hepatitis, thyroid disorders, asthma, respiratory disorders, rheumatoid arthritis, osteoporosis, joint pain, depression, and chronic fatigue syndrome.
- 31. Therefore, the making of the representations as set forth in Paragraph 29, above, constitutes a deceptive act or practice and the making of false advertisements in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a), 52.

COUNT THREE

False or Misleading Claims That Consumer Testimonials Reflect Independent Opinions

- 32. In numerous instances in connection with the advertising, marketing, promotion, offering for sale, or sale of Rejuvi-Cell, Rejuvi-Sea, and Rejuvi-Stem, including through the means described in Paragraphs 19 and 21, Defendants have represented, directly or indirectly, expressly or by implication, that consumer testimonials appearing in their advertising, including from individuals identified by the initials D.L.E. or D.E., D.C., and P.H., reflect the independent experiences or opinions of ordinary purchasers.
- 33. In truth and in fact, in numerous instances, consumer testimonials appearing in Defendants' advertising do not reflect the independent experiences or opinions of ordinary purchasers because the testimonials from D.L.E. or D.E., D.C., and P.H. were by, respectively,

Dorinda Lee Estrada, Daniel Cahill, and Patricia Henderson, who were employees of Defendant HCI when the testimonials were created and disseminated.

34. Therefore, the making of the representation as set forth in Paragraph 32 constitutes a deceptive act or practice and the making of false advertisements in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a), 52.

VIOLATIONS OF THE TELEMARKETING SALES RULE COUNT FOUR

Misrepresentations of Material Aspects of the Performance, Efficacy, Nature, or Central Characteristics of the Goods in Violation of the TSR

- 35. In numerous instances, in connection with the telemarketing of goods and services, Defendants have misrepresented, directly or by implication, material aspects of the performance, efficacy, nature, or central characteristics of such goods and services, including, but not limited to:
- A. Rejuvi-Cell treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, Alzheimer's disease, fibromyalgia, arthritis, emphysema, asthma, muscular dystrophy, obesity, high blood pressure, and high cholesterol;
- B. Rejuvi-Cell contains human somatotrophin, also known as human growth hormone (HGH);
- C. Rejuvi-Sea treats, mitigates, or cures multiple diseases and health conditions, including cancer, diabetes, arthritis, bone disease, pain, depression, obesity, and high blood pressure; and
- D. Rejuvi-Stem treats, mitigates, or cures multiple diseases and health conditions, including pulmonary disease, heart disease, diabetes, bone disease, arthritis, and pain.
- 36. Defendants' acts and practices, as described in Paragraph 35 above, are deceptive telemarketing acts or practices that violate the TSR, 16 C.F.R. § 310.3(a)(2)(iii), (a)(4).

CONSUMER INJURY

37. Consumers are suffering, have suffered, and will continue to suffer substantial injury as a result of Defendants' violations of the FTC Act and the TSR. In addition, Defendants have been unjustly enriched as a result of their unlawful acts or practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

THIS COURT'S POWER TO GRANT RELIEF

38. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of any provision of law enforced by the FTC, including the Telemarketing Act and the TSR. The Court, in the exercise of its equitable jurisdiction, may award ancillary relief, including rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies, to prevent and remedy any violation of any provision of law enforced by the FTC. Section 19 of the FTC Act, 15 U.S.C. § 57b, and Section 6(b) of the Telemarketing Act, 15 U.S.C. § 6105(b), authorizes this Court to grant such relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of the FTC Act and the TSR, including rescission or reformation of contracts, and the refund of money.

PRAYER FOR RELIEF

Wherefore, Plaintiff FTC, pursuant to Sections 13(b) and 19 of the FTC Act, 15 U.S.C. §§ 53(b) and 57b, Section 6(b) of the Telemarketing Act, 15 U.S.C. § 6105(b), and the Court's own equitable powers, requests that the Court:

- A. Enter a permanent injunction to prevent future violations of the FTC Act and the TSR by Defendants;
- B. Award such relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of the FTC Act and the TSR, including rescission or





AMINO ACIDS

Amino acids play central roles both as building blocks of proteins and as intermediates in metabolism. The 20 amino acids that are found within proteins convey a vast array of chemical versatility. The precise amino acid content, and the sequence of those amino acids, of a specific protein, is determined by the sequence of the bases in the gene that encodes that protein. The chemical properties of the amino acids of proteins determine the biological activity of the protein. Proteins not only catalyze all (or most) of the reactions in living cells, they control virtually all cellular process. In addition, proteins contain within their amino acid sequences the necessary information to determine how that protein will fold into a three dimensional structure, and the stability of the resulting structure. The field of protein folding and stability has been a critically important area of research for years and remains today, one of the great unsolved mysteries. It is, however, being actively investigated, and progress is being made every day.

As we learn about amino acids, it is important to keep in mind that one of the more important reasons to understand amino acid structure and properties, is to be able to understand protein structure and properties. We will see that the vastly complex characteristics of even a small relatively simple, protein are a composite of the properties of the amino acids which comprise the protein.

ESSENTIAL AMINO ACIDS

Humans can produce 10 of the 20 amino acids. The others must be supplied in food. Failure to obtain enough of even 1 of the 10 essential amino acids, those that we cannot make, results in degradation of the body's proteins...muscle and so forth...to obtain the one amino acid that is needed. Unlike fat and starch, the human body does not store excess amino acids for later use...the amino acids must be in the food that we consume every day.

The 10 amino acids that we can produce are alanine; asparagines; aspartic acid; cysteine; glutamic acid; glutamine; glycine; proline; serine and tyrosine. Tyrosine is produced from phenylalanine, so if the diet is deficient phenylalanine, tyrosine will be required as well. The essential amino acids are arginine (required for the young, but not for adults), histidine; isoleucine; leucine; lysine; methionine; phenylalanine; threonine; tryptophan and valine. These amino acids are required in the diet. Plants of course, must be able to make all the amino acids. Humans on the other hand, do not have all the enzymes required for the biosynthesis of all of the amino acids.

WHAT IS A TRACE MINERAL?

Most of us are familiar with the minerals our bodies need a high levels, such as calcium, magnesium, potassium and sodium. These minerals because they are needed by our bodies in significant amounts, are called macrominerals. A number of other minerals, required in much smaller levels by our bodies, but no less important to good overall health, are called microminerals, or more commonly tract minerals. Trace minerals are usually found at extraordinarily small levels in our bodies, in the parts per million range. In spite of the relatively low concentrations of these minerals, scientists are discovering that they play an increasingly vital role in our health, including the health of our bones and joints.

THE BENEFITS OF TRACE MINERALS

Do we need trace minerals? Yes! It is a certainty that a large number of trace minerals are directly linked to good bone health. Deficiencies of certain trace minerals, such as copper and manganese, for example, have been connected to lower bone density and weaker bones. While everyone is aware of the benefit calcium has on bone health, studies show that supplementing with calcium and trace minerals together, increases bone density in post-menopausal women more than calcium alone. In other words, calcium alone is NOT enough. A two year, double-blind, placebo controlled trial suggests that bone loss in post-menopausal women can be stopped WHEN TRACE MINERAL INTAKE IS INCREASED! The women in the study who took calcium alone, only showed their rates of bone loss. While the mechanisms of how trace minerals function in our bodies may not be entirely known, it is becoming clear that they are necessary for preserving bone mass and for general health aw well! There are 60 minerals found in human blood and known to be needed in the diet on a regular basis. Human milk also contains 60 minerals, including some, such as nickel and vanadium that were previously thought to be unimportant.

Because these minerals are found in our blood and in mothers' milk, our bodies probably have some use for them, even though science has not yet identified the usefulness of each trace mineral.

WE ARE LOSING NUTRIENTS!

It is astonishing, yet little published fact, that many of our foods don't contain the same levels of nutrition as they once did. The reasons aren't entirely known, but since the early 1960's the levels of vitamins and minerals in our produce and meat have dropped significantly. Did you know, for example, that broccoli today has on 50% of the calcium it did in 1963? The potassium level in beets has dropped by 10% over that same time period, and spinach has 10% less magnesium! Going back to the 1930's, vegetables have lost about half of their sodium and calcium content, a quarter of their iron and 76% of their copper content. The nutrient levels of fruit has declined significantly with copper, iron, and zinc all falling by up to 27%. Ten other vitamins and minerals have shown a 5% to 35% decline in our fruit and vegetables over the past 50 years. Some cattle farmers are even finding lower levels of trace minerals in our beef and have begun supplementing their animals with minerals that are obviously lacking in their feed! While many of us have never heard about this loss of nutrition, scientists have even given it a name, they call this phenomenon "the dilution effect". Farmers get paid by the weight and appearance of their product, so they have been focused on growing large, beautiful fruit and vegetables, but the nutritional value has washed out! Clearly our soil isn't providing the same nutrients to our foods as it once did. Trace minerals in spirulina are present in a highly bio-available and absorbable form. Unlike minerals found in rock and other inorganic supplements, the minerals in spirulina have become part of the algae plant, bound to amino acids and other building blocks of life. Studies have shown that minerals in this form have higher absorption rates from the intestines. Inorganic rock minerals can combine with other compounds to form insoluble blocks that are not absorbed by the gut. You can't simply add more inorganic minerals to a supplement to overcome this problem! In fact, studies have shown that doubling the amount of inorganic copper or zinc minerals will depress the overall benefit of the mineral. Spirulina is the clear choice when it comes to bone health supplementation. THE BONE HEALTH BENEFITS OF NICKEL

Unfortunately, there isn't very much information in the benefits of nickel to our bone health. We do know, however, that if you do not have enough nickel in your diet, it can affect the distribution and functioning of other nutrients in the body, including calcium. Given the obvious benefit calcium has on our bones, it isn't difficult to see that maintaining adequate levels of nickel is therefore an important factor in maintaining or building healthy bone!

THE BONE HEALTH BENEFITS OF SELENIUM

Selenium appears to be one of the least understood trace minerals in terms of how it impacts bone and joint health, but studies show that it does appear to have a positive impact.

In a recent study, scientists clipped the toenails of 940 volunteers and measured the amount of selenium in each sample. They also tested the volunteers for incidence of osteoarthritis. They found that the group of volunteers who had osteoarthritis, also had lower levels of selenium in their bodies than people in the group who didn't have osteoarthritis. While the scientists are not sure how low levels of selenium contribute to osteoarthritis, they found that for every additional 0.1 parts per million of selenium in the toenails, there was a 15% to 20% lower risk of osteoarthritis in the knees! In another study, scientists used Heparin (a blood thinning drug) on rabbits to induce conditions of osteoporosis. Once the rabbits exhibited the signs of osteoporosis, they were given a combination of vitamins E and C. While these vitamins helped partially prevent osteoporosis in the rabbits. Once selenium was added to the mix, the rabbits' bone structure virtually returned to normal!

THE BONE HEALTH BENEFITS OF VANADIUM

Vanadium is another trace mineral that we do not understand the role of very well, yet it clearly has an effect on the health of our bones. In research with goats, scientists have noted skeletal deformations in the legs of vanadium deprived goats. As part of in-vitro tests on bone cells, vanadate, a compound containing vanadium, has been shown to stimulate bone cell proliferation. It was also shown to stimulate collagen (the organic part of bone that provides strength and flexibility) synthesis. Vanadium has also shown that it helps promote bone health without negative side effects. In a study involving both diabetic and non-diabetic rats, vanadium compounds were shown to increase bone formation without any adverse health effects!

THE BONE HEALTH BENEFITS OF ZINC

The mineral zinc is another metal that helps us maintain bone health. Studies have found zinc to be ESSENTIAL in bone metabolism as a co-factor for specific enzymes and has been proven effective in increasing the spinal bone mass density of post-menopausal women. Appropriate doses of zinc can help prevent osteoporosis! Zinc also plays a role in the activity of osteoblasts in our bodies, the cells that actually build up our bone. It aids in the production of collagen and has also been correlated with low insulin growth factors, something scientist speculate is associated with age related bone loss!
